<u>Derbyshire County Council - Warm and Welcoming Spaces</u> <u>Grants</u>

Voluntary, community and charity organisations in Derbyshire can apply for a grant to set up warm and welcoming spaces this winter.

Derbyshire County Council have launched a warm and welcoming spaces fund to support organisations to provide a warm refuge for residents and their families struggling to heat their homes.

Organisations can apply for up to £1,000 towards the cost of opening up community venues or to extend their opening hours during the colder months.

The amount of grant funding awarded will be determined following assessment of eligibility criteria, consideration of the amount of hours that the warm and welcoming space will be open (especially at evenings and weekends), and the number of potential beneficiaries.

Applications will be accepted up to 1 March 2024, or until the funding allocated to the programme has been fully spent (whichever is sooner).

To qualify for a grant, organisations must pledge to offer a heated space during the winter months, provide seating, offer refreshments such as a warm drink and a biscuit, and be free of charge.

If you are an organisation or charity that's running a warm and welcoming space, register your venue with the <u>Warm Welcome Spaces Campaign</u> so residents can find you.

<u>Erewash Voluntary Action CVS – Erewash Small Grant</u> Scheme

Derbyshire County Council Public Health, Derbyshire County Council Adult Care Services and Erewash Borough Council fund the Erewash Small Grant Scheme.

Community groups and organisations can apply for up to £1,500.

The Erewash Small Grant Scheme has three priority themes and applicants must meet at least one of the themes to be eligible to apply. The priority themes include:

- Health Inequalities
- Community Wellness
- Building Resilience

Applications can be made by voluntary or community groups with a constitution, registered charity or charitable incorporated organisation, community interest company or social enterprise and other not for profit organisations.

The grant scheme is not open to statutory organisations. From 1 August 2023 this includes Parish Councils.

<u>Erewash Borough Council – Fast Funding Community</u> Grants

The council has received Shared Prosperity Funding (SPF) from central government, to support its revised Fast Funding Community Grant scheme. Qualifying community organisations, including registered charities, voluntary organisations and social enterprises, are invited to apply for a grant of up to £1,500 to deliver a project or activity that will provide benefits for Erewash residents.

All applications must show how their project or activity will achieve one or both of the Fast-Funding Community Grant scheme's outcomes:

• Increased engagement (of at least 10%).

Increased volunteering (of at least 10%).

<u>Derbyshire County Council Public Health Covid</u> Community Fund 2023-2024

The COVID-19 Community Fund aims to support voluntary and community sector organisations by providing much needed funding. This allows them to continue to play a key role in the local response to COVID-19 and to improve the health and wellbeing of Derbyshire residents.

The funding is for organisations and projects that meets at least one of the criteria below:

- support to increase COVID-19 vaccination uptake
- protect people most vulnerable to COVID-19
- increase mental health and wellbeing and support individual and community resilience
- promote safer behaviours to reduce future risk of infection
- directly address health inequalities arising from, or made worse, by the pandemic

Constituted organisations and groups can apply for up to £2,000 in funding, and non-constituted organisations and groups up to £250.

If you have previously received a grant from the COVID-19 Community Fund, you are eligible to reapply. However, the second application must not be a duplication of the original request. an Organisations could re-submit an application that has previously been rejected if it meets the new criteria.

The fund closes on 31 March 2024 applicants are advised to apply early.

<u>Derbyshire County Council Members Community</u> <u>Leadership Scheme</u>

Each County Councillor usually has £3,860 to give to local groups, this year an additional £3,860 has been allocated bringing their total to £7,720.

All 64 of our councillors get funding through the members' Community Leadership Scheme to give to communities and organisations in their area.

Groups seeking funding should contact their local county councillor to explain the nature of the project, amount sought, what other funding is available and how it will benefit the community.

National Lottery Community Fund - Awards for All England

Voluntary, community organisations and Schools, etc across the UK can now apply for grants of up to £20,000 from the National Lottery Community Fund – Awards for All programme. This represents a significant increase from the previous maximum grant size of £10,000. Projects can last for up to two years.

The funding boost is intended to support organisations in delivering new or existing community led activities. Eligible projects must achieve at least one of the following objectives:

- Bring people together to build strong relationships within and across communities
- Improve places and spaces that matter to communities
- Help individuals reach their potential by providing early support
- Assist individuals, communities, and organisations facing difficulties due to the cost-of-living crisis

Organisations eligible to apply include:

- Constituted voluntary or community organisations
- Constituted groups or clubs
- Registered charities
- Charitable incorporated organisations (CIOs)
- Not-for-profit companies
- Community interest companies (CICs)
- Schools (provided the project benefits and involves the surrounding communities)
- Statutory bodies (including local authorities, town, parish, and community councils)
- Community benefit societies

The application deadline is 16 weeks before the start of the project or activities.

<u>Department for Culture, Media and Sport - VCSE Energy</u> <u>Efficiency Scheme</u>

Eligible voluntary, community, and social enterprise (VCSE) organisations in England can now apply for funding to help them reduce their energy costs and improve their energy efficiency. The £25.5 million VCSE Energy Efficiency Scheme is part of a package of over £100 million of support being delivered by the government to help frontline delivery organisations with the increased cost of living.

The VCSE Energy Efficiency Scheme is being provided by the Department for Culture, Media and Sport (DCMS). The scheme is being delivered by a consortium of The VCSE Energy Efficiency Scheme is open to voluntary, community, and social enterprise (VCSE) organisations in England that meet the following criteria:

- Must be a registered VCSE with a charity number
- Must have a turnover of less than £25 million
- Must be based in England
- Must be responsible for the premises they wish to improve

The VCSE Energy Efficiency Scheme offers two types of funding:

- Independent energy assessment: Organisations can apply for funding to cover the cost of an independent energy assessment. This assessment will help identify the most effective measures for reducing their energy costs. This part of the scheme is now open for applications and will remain open until August 2024.
- Capital grant: Organisations that have received an energy assessment may be eligible for a capital grant to install the recommended energy efficiency measures in their premises. This part of the scheme will open to applications in January 2024 and grant rounds will also run until August 2024.

The funding can be used to install a range of energy efficiency measures, including:

- LED lighting
- Energy-efficient heating and ventilation
- Insulation
- Smart meters

The deadline for applications is 31 August 2024.

National Churches Trust - Gateway (Medium) Grant Programme

Grants of up to £10,000 are available to listed and unlisted Christian places of worship, of any denomination, across the UK towards project development and investigative work up to RIBA planning stage 1, to support churches preparing for a major project, and in developing their project to the point at which they can approach a major grant funder. Grants will never exceed 50% of the net project costs for this phase.

The National Churches Trust's Medium Grants Programme is also now able to offer grants of up to £10,000 for urgent and essential maintenance and repair projects costing between £20,000 and £80,000. Grants will never exceed 50% of the net project costs.

The deadline for applications is midnight on the 16 April 2024.

The Seven Friends Foundation

The Seven Friends Foundation provides small grants up to £3,000 to organisations that fulfil their charitable aims:

- To support and promote causes that are ignored, unpopular or face widespread stigma
- Create stronger local communities that include those who have previously been excluded or marginalised
- Improve skills, infrastructure, sustainability and collaboration within the third sector. The foundation will support small organisations, typically meaning those with an average annual income of under £300,000.

Grants are available to both registered charities and other organisations which are not charities but which seek funding for charitable work, however, these organisations may be asked to provide additional evidence.

The foundation will support organisations working anywhere within the UK but has a preference for those located in areas of deprivation.

The types of causes and groups that may receive funding include:

- Asylum seekers and refugees
- Migrant communities
- Offenders and ex-offenders
- People experiencing violence or abuse.

The deadline for applications is 1 February 2024

Jean Sainsbury Animal Welfare Trust

Charities registered in the UK and working to offer sanctuary, rehoming and rehabilitation to animals in the UK and/or internationally can apply for grants through the Jean Sainsbury Animal Welfare Trust.

Organisations involved with the conservation of wildlife, the rescue, rehabilitation and (where possible) release of animals are also eligible to apply. The funding supports general running costs or capital purchases.

The Trust encourages repeat applications from charities when further financial support might be given if funds allow.

In the past the maximum grant awarded has been £35,000

Kelly Family Charitable Trust

Registered charities whose activities support and encourage the family to work as a cohesive unit in tackling problems that face one or more of its members can apply for grants of up to £5,000 (but trustees will consider requests for higher amounts) through the Kelly Family Charitable Trust.

The Trust will consider both capital and revenue grants. The Trust is happy to support requests for core funding as well as project-based grants, and actively encourages applications from relatively new organisations to help them become established.

The three areas of activity that the charity wishes to support are:

- Interventions that support families and help them in ways that prevent the fracture of the family unit, e.g. practical family support, relationship counselling, mediation.
- Families where sexual abuse, physical abuse, domestic violence, alcohol abuse and drug abuse threaten the integrity of the family unit.
- Prisoners and in particular their families, during and after the period of imprisonment.

The trust prefers to support charities whose income is below £500,000. However, larger charities with pioneering pilot projects will be considered.

The closing date for applications is 1 March 2024

Golsoncott Foundation

Arts organisations across the UK can apply for grants of up to £3,000 to deliver projects that demonstrate and deliver excellence in the arts.

The funding is made available by the Golsoncott Foundation, an arts-funding trust whose objective is to promote, maintain, improve and advance the education of the public in the arts, particularly the fine arts and music.

Priority is given to applications from arts organisations whose *raison d'être* is the art form itself, and its perfection or excellence in performance.

The trustees meet four times a year.

The deadline for the next meeting is the 10 February 2024.

Cadent Foundation - Winter Support Fund

A new £2 million fund has been launched to provide energy and food support to vulnerable people across the UK during the winter months.

The Cadent Foundation's Winter Support Fund will allow charities offering energy and money guidance, to have rapid access to additional financial resources, helping to make an immediate impact for people needing extra support.

The food and energy vouchers will be available to people who are living in the most vulnerable situations and who Cadent Foundations' current charity partners, including the Trussell Trust and Citizens Advice, are supporting with energy efficiency and money management guidance. Each household will receive up to two vouchers, with the option of also having up to £100 to spend on essential heating and cooking appliances, such as heated blankets, slow cookers and air fryers.

The funding will be distributed through the Foundation's current charity partners, including Citizens Advice, Groundwork UK and Trussell Trust.

The support will be available between December 2023 and March 2024.

The deadline is 31 March 2024

National Archives - Engagement Grants Programme

This year the grants will be themed around the concept of "Place", with grants of up to £5,000 available for projects that will engage with new and existing audiences in the places and communities where archives are located.

The funding is available to museums and other public bodies, registered charities and not for profit organisations that hold collections in England and Wales. Eligible costs include:

- exhibitions
- events
- online or digital engagement
- materials
- staff time
- travel and subsistence
- materials or software

The closing date for applications is the 26 January 2024.

Ford Britain Trust

Registered charities, not-for-profit organisations, and schools/PTAs can apply for grants of up to £3,000 for projects that are of benefit to their local community.

The funding is made available by the Ford Britain Trust to support a range of projects focusing education, environment, children, the disabled, youth activities and projects that provide clear benefits to the local communities.

Applications will be considered from all UK locations. However, organisations based in Essex (including East London), Bridgend) including South Wales), Southampton, Daventry, Manchester and Liverpool - areas close to Ford locations – will be given priority.

Funding will support capital projects such as refurbishments, or expenditure on items such as furniture, equipment or computers.

There are two types of grants to apply for:

- Small grants for amounts up to £250. The small grants programme is currently closed.
- Large grants for amounts over £250 and up to a maximum of £3000.

The deadline for applications to the large grants programme is the 31 January 2024.

FCC Community Foundation

Registered Charities, churches, Parish Councils, Local Authorities and CASC registered sports clubs can apply for grants of between £2,000 and £100,000 for the provision, maintenance or improvement of community facilities.

This can include:

- Village Halls and Community Centres;
- Public Play Areas;
- Publicly available Multi use games areas;
- Skate parks and BMX tracks;
- Sport and recreation grounds including pavilions and clubhouses with full public access;
- Churches community spaces only;
- Nature Reserves;
- Public gardens, parks, country parks and woodlands with at least dawn to dusk access;
- Museums.

The funding is being made available through the FCC Community Action Fund and is available to projects located within 10 miles of an eligible FCC Environment site.

Recent changes to its funding policy mean that the FCC Community Foundation will now accept applications for renewable energy projects based at community buildings, including solar panels. Applications for non-substantial extensions such as porches, storage areas and toilets/kitchens will in some circumstances will now also be accepted.

All grants require applicants to secure a <u>contributing third party (CTP) payment</u>. This is a very specific payment required to be paid to the landfill operator and should not be confused with match funding.

<u>Armed Forces Covenant Fund Trust - Veterans' Career</u> <u>Development Fund</u>

UK charities, community interest companies and universities can apply for funding for projects that help Veterans and their families.

UK charities, community interest companies and universities can apply for funding for projects that help Veterans, and their families secure stable long-term employment.

Under the Veterans' Career Development Fund, organisations can apply for grants of up to £70,000 over two years for projects that provide Veterans and their families with the qualifications and training they need to access meaningful employment.

Applications are encouraged for projects that support Veterans who are facing particular barriers. This might include:

- those who are not involved in education or have limited qualifications
- women Veterans
- LGBT+ Veterans
- early Service leavers
- Veterans with health challenges
- Veterans from minority ethnic communities
- those aged 50+ looking to re-enter the workforce

•

Collaborative projects are encouraged.

The funding is delivered by the Armed Forces Covenant Fund Trust on behalf of the Office for Veterans' Affairs.

Grow Wild - Community Grant

Grants can run for 1-3 years, and there are no restrictions on what resources the funding can be used to pay for.

Funding Reminders

Lloyds Bank Foundation - Specialist Small Charities

This programme is for small, local, specialist charities supporting people facing complex issues. We support charities that help people overcome complex issues that do not have simple solutions, issues like homelessness, domestic abuse and addiction. That is why we support small charities with an annual income between £25,000 to £500,000 where the main focus of your charity is to provide support for one of the eight themes outlined below:

We want to ensure that the charities we support can thrive beyond the lifetime of our funding. That is why we combine an unrestricted grant of £75,000 with a breadth of tailored support aimed at helping to strengthen charities and build the knowledge, skills and capabilities of staff and trustees.

John Ellerman Foundation - Museums and Galleries Fund

The Museums and Galleries Fund aims to help strengthen museums and galleries in the UK, celebrating the unique assets that our regions possess and their benefit to us nationally. We want to help organisations enhance and sustain curatorial development to attract a broader and more diverse public. We have earmarked 10 per cent of our overall grants budget for the 2024/25 financial year to be awarded through the Fund, with final decisions made in May 2024 for this round.

We generally expect to make five or six grants for periods of two to three years. While the average grant size is circa £90k we will consider higher amounts for exceptional projects.

What we will fund - We are keen to fund work which has a legacy within and beyond the organisation. We prioritise applications that aspire to achieve outcomes for people working in curatorial roles, the collections they work with and the institutions in which they work.

We are particularly interested in proposals which:

- enable new ways of working through innovation, new thinking and fresh approaches both for established curators or those just starting out and/or •
- ensure organisations are able to safeguard and advance curatorial skills and conservation skills and make the most of opportunities at a time of development or change.

Who can apply - The Fund is open to a wide variety of collection types. We have supported visual and decorative arts, social history and anthropology, science and technology, industrial, natural history collections. In line with our general policy, we favour organisations with an income between £100,000 and £10m but may fund a larger institution if it is uniquely placed to meet our aim.

Local authority, independent museums and contemporary galleries without permanent collections are also eligible.

First-stage applications must be received by 5pm on Monday 8th January 2024.

Big Give Green Match Fund

The Big Give Green Match Fund is now accepting applications from environmental charities seeking match funding of up to £100,000 to support their projects. - Work- or education-related expenses (interview clothes, school uniforms, laptops)
- Rent arrears and Council tax arrears, but only where there is a clear and obvious risk of homelessness (for rent arrears involving a social landlord please outline what support has already been offered to your tenant)
- Contribution to immigration-related costs, where the current immigration status directly causes financial hardship to the applicant

Applications can be made at any time and are assessed every six weeks.

BlueSpark Foundation

Schools, colleges and community groups in England can apply for grants to BlueSpark Foundation to support the education and development of children and young people through educational, cultural, sporting and other projects.

BlueSpark is particularly keen to support projects which will help enhance the self-confidence, team working skills and future employability of children and young people. In most cases, grants will be made on a relatively small scale.

The Foundation makes grants of up to £5,000. The majority of grants awarded however, are below £2,000.

The funding available can be for physical assets (such as iPads, sports equipment, or lighting for stage productions) or for services or facilities (such as sports coaching or music or drama tuition) or simply for the provision of experiences (such as theatre visits). These examples are intended to be illustrative and not restrictive as to the funding which BlueSpark may provide to support projects.

Applications are reviewed on a rolling basis at approximately 8-week intervals.

Sport England - Small Grants Programme

Sport England has widened its Small Grants programme to provide support for projects that deliver environmental benefits for local communities.

The programme will not only provide funding to encourage greater participation in sport and physical activity, but it will also award grants of up to £15,000 for projects that benefit the environment.

This could include:

- Reducing energy use by installing energy meters or measures to improve insulation/ventilation to help reduce your energy usage; automatic controls to switch lights and electrical equipment off; using LED bulbs; or staging lower impact events and competitions.
- Encouraging responsible travel. This could include encouraging people to walk or cycle where possible and providing safe cycle/scooter/buggy storage options; promoting accessible and safe public transport routes and lift sharing; and using local community assets to minimise travel.
- Reducing waste and resource efficiency. This could include encouraging
 people to repair, recycle or re-use sports equipment or starting a kit and
 equipment donation scheme; offering more environmentally sustainable
 food and drinks packaging; reducing use of single-use plastics, for example
 by providing water-refill stations at your venue and encouraging participants
 to bring reusable bottles.

Eligible organisation that can apply include voluntary, community and social enterprise organisations, schools and local authorities.

The closing date for applications is the 31 March 2024.

<u>Trusthouse Charitable Foundation - Small Grants</u> <u>Programme</u>

Charities and not for profit organisations in the UK can apply for small grants of up to £10,000 to address urban and rural deprivation in the UK. The funding is being made available through the Trusthouse Charitable Foundation's small grants programme.

To be eligible for a grant, eligible organisations must have an annual income of less than £250,000. They must also be able to demonstrate a clear need for funding and how the grant will be used to make a difference. In addition the applicants postcode must be located within the following areas on the Indices of Multiple Deprivation:

- For projects located in an urban area, the applicant must be in the bottom 15% most deprived areas
- For projects located in a rural area, the applicant must be in the bottom 50% most deprived areas

The funding is available to support project/salary/core running costs.

Applicants need to match fund 50% of the project costs.

Applications for the small grants scheme can be submitted at any time.

<u>Henry Smith Charity - Strengthening Communities</u> <u>Programme</u>

Grants of between £20,000 and £70,000 per year for up to three years are available to community-led charities and not-for-profit organisations working to support communities in the most deprived areas of the UK.

The Henry Smith Charity's Strengthening Communities programme focuses on supporting the running costs of organisations working at grass-roots level, to ensure that funding reaches the most disadvantaged areas.
