### National Lottery Heritage Fund

The Heritage 2033 strategy is centered around a simplified framework of four investment principles:

- Saving heritage
- Protecting the environment
- Inclusion, access and participation
- Organisational sustainability

The entry level has now been increased to £10,000. The application guidance and forms have been changed to reflect the new strategy and materials have been simplified proportionate to the amount of money you are applying for.

### <u>Women's Aid – Flexible Fund</u>

Women's Aid is pleased to be working with the Home Office and sector partners to help distribute an additional funding to provide one-off payments to survivors of domestic abuse to help them flee from their abuser, and to increase their stability and independence following on from a successful pilot distributed in May 2023.

From Wednesday 31st January 2024 until Sunday 31st March 2024, survivors of domestic abuse who do not have the financial means to leave their abusers, or to remain safely in their home, will be able to apply for a one-off payment of up to £500 for essential items such as groceries, nappies or clothing to help them and their children flee to safety.

For the first time, survivors can also apply for a further one-off payment of up to  $\pounds 2,500$  to help secure a sustainable independent future, such as putting down a deposit for rental accommodation.

#### <u>Derbyshire County Council - Warm and Welcoming Spaces</u> <u>Grants</u>

Voluntary, community and charity organisations in Derbyshire can apply for a grant to set up warm and welcoming spaces this winter.

Derbyshire County Council have launched a warm and welcoming spaces fund to support organisations to provide a warm refuge for residents and their families struggling to heat their homes.

Organisations can apply for up to £1,000 towards the cost of opening up community venues or to extend their opening hours during the colder months.

The amount of grant funding awarded will be determined following assessment of eligibility criteria, consideration of the amount of hours that the warm and welcoming space will be open (especially at evenings and weekends), and the number of potential beneficiaries.

Applications will be accepted up to **1 March 2024**, or until the funding allocated to the programme has been fully spent (whichever is sooner).

To qualify for a grant, organisations must pledge to offer a heated space during the winter months, provide seating, offer refreshments such as a warm drink and a biscuit, and be free of charge.

If you are an organisation or charity that's running a warm and welcoming space, register your venue with the **Warm Welcome Spaces Campaign** so residents can find you.

#### <u>Erewash Voluntary Action CVS – Erewash Small Grant</u> <u>Scheme</u>

Derbyshire County Council Public Health, Derbyshire County Council Adult Care Services and Erewash Borough Council fund the Erewash Small Grant Scheme.

Community groups and organisations can apply for up to £1,500.

The Erewash Small Grant Scheme has three priority themes and applicants must meet at least one of the themes to be eligible to apply. The priority themes include:

- Health Inequalities
- Community Wellness
- Building Resilience

Applications can be made by voluntary or community groups with a constitution, registered charity or charitable incorporated organisation, community interest company or social enterprise and other not for profit organisations.

The grant scheme is not open to statutory organisations including Parish Councils.

#### <u>Erewash Borough Council – Fast Funding Community</u> <u>Grants</u>

The council has received Shared Prosperity Funding (SPF) from central government, to support its revised Fast Funding Community Grant scheme. Qualifying community organisations, including registered charities, voluntary organisations and social enterprises, are invited to apply for a grant of up to £1,500 to deliver a project or activity that will provide benefits for Erewash residents.

All applications must show how their project or activity will achieve one or both of the Fast-Funding Community Grant scheme's outcomes:

- Increased engagement (of at least 10%).
- Increased volunteering (of at least 10%).

### Derbyshire County Council Public Health Covid Community Fund 2023-2024

The COVID-19 Community Fund aims to support voluntary and community sector organisations by providing much needed funding. This allows them to continue to play a key role in the local response to COVID-19 and to improve the health and wellbeing of Derbyshire residents.

The funding is for organisations and projects that meets at least one of the criteria below:

- support to increase COVID-19 vaccination uptake
- protect people most vulnerable to COVID-19
- increase mental health and wellbeing and support individual and community resilience
- promote safer behaviours to reduce future risk of infection
- directly address health inequalities arising from, or made worse, by the pandemic

Constituted organisations and groups can apply for up to £2,000 in funding, and nonconstituted organisations and groups up to £250.

If you have previously received a grant from the COVID-19 Community Fund, you are eligible to reapply. However, the second application must not be a duplication of the original request. an Organisations could re-submit an application that has previously been rejected if it meets the new criteria.

#### The fund closes on 31 March 2024 applicants are advised to apply early.

### East Midlands Airport Community Fund

Communities around East Midlands airport can apply for grants of up to £2,000 for projects that have a long-lasting community, social or environmental benefit.

Applications must meet at least one of the following objectives:

- bring the community closer together through facilities for sport, recreation and other leisure-time activities;
- support young people to prepare for employment;

### Boots Charitable Trust

Boots Charitable Trust is an independent registered charity wholly funded by Boots UK Limited. The Trust recently expanded its grant programme from its home base of Nottinghamshire to across the UK.

Registered charities working in areas of health, lifelong learning, community development and social care can apply four times a year for grants of between £100 and £10,000.

Grants of up to £5,000 are available for smaller voluntary organisations whose income and expenditure is less than £5,000 per year and who are not registered with the Charity Commission.

To be eligible projects must at least one of the Trust's four funding priorities:

- Health community healthcare such as homecare or support for those with medical conditions and health education and prevention.
- Lifelong learning local literacy and numeracy projects
- Community development providing volunteer services

There are four application windows per year and applications will only be accepted during the quarterly windows.

### <u>Agbero 2100</u>

Agbero 2100 is a strategic intervention developed by The Ubele Initiative in 2023. The intervention is designed to provide long term support and resources to black and racially minoritised communities with the aim of creating sustainable communities, developing community assets, fostering intergenerational leadership and promoting community enterprise.

Agbero 2100 will provide infrastructure support to up to 50 black and racially minoritised community based organisations selected across England.

The support offered will focus on the following six areas:

- Governance and Leadership
- Operations and Infrastructure
- Financial Resources
- Physical Asset Ownership
- Impact and Effectiveness
- Connectedness and Engagement

#### Volunteering for Health

Volunteering for Health is a £10m programme that is being delivered through a partnership between NHS Charities Together, NHS England, and CW+. Building on the recommendations of the NHS Volunteering Taskforce, it will deliver grant funding and tailored support to around 15 local systems in England.

The programme will speed up change by helping to break down barriers to volunteering, test new volunteering infrastructure models, and develop guidance and best practice for all systems. It aims to influence the policy environment and increase our understanding of the impact of volunteers and volunteering across the NHS, alongside the potential role of NHS charities in helping the NHS to deliver the best care.

The fund is now open for Phase 1 applications.

### National Lottery Community Fund - Awards for All England

Voluntary, community organisations and Schools, etc across the UK can now apply for grants of up to £20,000 from the National Lottery Community Fund – Awards for All programme. This represents a significant increase from the previous maximum grant size of £10,000. Projects can last for up to two years.

The funding boost is intended to support organisations in delivering new or existing community led activities. Eligible projects must achieve at least one of the following objectives:

- Bring people together to build strong relationships within and across communities
- Improve places and spaces that matter to communities
- Help individuals reach their potential by providing early support
- Assist individuals, communities, and organisations facing difficulties due to the cost-of-living crisis

Organisations eligible to apply include:

- Constituted voluntary or community organisations
- Constituted groups or clubs
- Registered charities
- Charitable incorporated organisations (CIOs)
- Not-for-profit companies
- Community interest companies (CICs)
- Schools (provided the project benefits and involves the surrounding communities)
- Statutory bodies (including local authorities, town, parish, and community councils)
- Community benefit societies

The application deadline is 16 weeks before the start of the project or activities.

### The Leathersellers Company

#### <u>Peter Harrison Foundation - Opportunities Through Sport</u> <u>Grant Scheme.</u>

Charities and Community Amateur Sports Clubs (CASCs) throughout the United Kingdom can apply to the Peter Harrison Foundation Opportunities Through Sport grant scheme. The aim of the grant scheme is to provide opportunities for sport and physical activity at a grassroots level that enable people who are physically, mentally, socially, or economically disadvantaged to develop personal and life skills to fulfil their potential.

The grants can be used for a variety of purposes, such as funding new sports programmes, improving existing sports facilities, or providing training and support for sports coaches.

The Trustees welcome applications for physical activity initiatives that:

- Provide a focus for skills development and confidence building
- Have a strong training and/or educational theme
- Provide specialised sporting equipment or facilities required to open opportunities
- Have a high degree of involvement from beneficiaries and those with lived experience
- Have a plan for sustainability and seek to deliver a lasting legacy

The Foundations provide two levels of funding:

- Major grants: between £5,001 and £30,000.
- Small grants: up to £5,000

Priority will be given to organisations with an annual turnover of up to £500,000.

### The Matthew Good Foundation

The Matthew Good Foundation has opened the next round of its Grants for Good Fund. The aim is to support small charities, not-for-profit groups and social entrepreneurs who are passionate about making a difference to people, their community or the environment.

The Fund will share £15,000 between five shortlisted projects every three months, which will be voted for by John Good Group employees. The project that receives the most votes will receive a grant of £5,000, second place £3,500, third place £2,500 with fourth and fifth place both receiving £2,000.

As well as established projects and charities, the Foundation wants to hear from people with innovative ideas that need some funding to get their projects up and running.

To be eligible, applicants will have to have had an income of less than £50,000 in the last 12 months.

Charities, social enterprises, and private companies can apply for funding for projects and activities that help to create fairness and sustainability in the economy. Support for the development of new economic ideas and approaches that push for and create a more just and sustainable economy based on the four D's:

- Diversified
- Decarbonised
- Democratised
- Decentralised

Most grants will be in the region of £50,000 - £75,000 and are available to support project and/or core funding.

Small grants of up to £10,000 are also available to develop the ideas of underresourced or newer entrants to economic systems change work. Applications for small grants can be submitted at any time.

#### Action with Communities in Rural England - Platinum Jubilee Village Hall Improvement Grant Fund

Village halls across England can apply for grants to improve and modernise their facilities.

Launched by the Department for Environment, Food & Rural Affairs to mark the Queen's Platinum Jubilee in 2022, the Platinum Jubilee Village Hall Improvement Grant Fund will provide capital only grants of up to £5,000 for capital improvement projects to create welcoming spaces that encourage more people to make use of their village halls and bring people together.

The fund is being managed by Action with Communities in Rural England (ACRE).

Activities should seek to achieve one or more of the following outcomes for their communities:

- improved health and/or wellbeing and/or reduction in rural loneliness
- positive impact on the local environment, contributes towards net zero
- support for the local rural economy
- promotion of community cohesion
- Grants are intended to support smaller capital projects such as:
- boiler replacements
- insulation
- toilet upgrades
- new kitchens

Awards can be made to cover 20% of eligible project costs.

### PRS for Music Foundation - Women Make Music

The PRS for Music Foundation's Women Make Music scheme is open for applications from female, trans, and non-binary songwriters and composers of all genres and backgrounds at various stages of their careers.

### **D'Oyly Carte Charitable Trust**

Grants are available for UK registered charities seeking to enhance and improve people's lives through the advancement of the arts, health and medical welfare, and the environment.

The D'Oyly Carte Charitable Trust typically awards grants of between  $\pounds$ 500 and  $\pounds$ 6,000 for projects and core costs, with a preference for small-scale, locally based initiatives.

The types of services provided to communities could include:

- Arts: Promoting access to the arts, providing performance development opportunities for early-career artists, and supporting charities that engage young people on the fringes of society through music and drama projects
- Environment: Conserving the countryside, encouraging voluntary work and active involvement in hands-on activities, particularly those that benefit young people, and supporting rural crafts and skills in heritage conservation
- Medical Welfare: Supporting charities that alleviate the suffering of adults and children with medical conditions, providing music and art therapy to improve quality of life, and providing breaks for carers without regular support

There are three grant-making meetings held annually which take place in March, July, and November.

Projects should have a start date of at least three months after the meeting date.

### **Pixel Fund**

Funding is available for registered charities that are core-focused on mental-healthrelated matters.to support projects that promote the mental health and wellbeing of children and young adults across the UK.

The funding is made available by the Pixel Fund, which generally awards grants of between £2,500 and £5,000 for specific projects that will provide a measurable difference to children and young adults under 26 years old.

No single grant is ever more than 5% of the annual income of an organisation and charities will need to have submitted at least a first full set of accounts on the Charity Commission website before the Fund will consider granting to an organisation.

Organisations should contact the Pixel Fund in the first instance. Eligible organisations will be invited to submit a full application.

#### Grow Wild - Youth Grants Programme

Grants of £500 are available for youth-led projects that celebrate UK native wildflowers, plants and fungi in exciting and engaging ways.

The funding is made available to individuals and groups of young people through Grow Wild's Youth Grants programme to support young people to deliver a wide range of creative projects that will inspire communities and help people connect to each other and nature.

Grants can be used for anything project-related, from basic materials and equipment to resources or training.

Young people aged 14 to 25 can apply directly as an individual or as a group of up to 6 people, but will need to nominate a youth, community or education-focused organisation to support them with their project.

Successful projects can be started in May and must be completed by the end of October 2024.

#### Moto in The Community Trust

Charities, schools and community organisations operating within a 15-mile radius of a Moto Motorway Services site can apply for funding for projects and activities that deliver benefits to local communities across the UK.

Moto in The Community Trust will fund different types of projects provided they directly benefit the communities where Moto is present or where it has a significant staff catchment.

The average grant awarded is £1,000, however, larger grants maybe agreed. In addition, successful applicants will be able to promote their organisation at their Moto service area and will be entitled to one collection day per year in their nearest Moto. Note that any application that is submitted should have the endorsement of a Moto colleague; that is someone directly employed by Moto Hospitality Ltd.

**Applications can be made at any time.** The application to approval process can take up to 8 weeks to complete.

### The Hubbub in the Loop Grant Fund

Funding is available for initiatives that improve recycling facilities in public spaces across the UK. The Hubbub in the Loop Grant Fund will award two projects with grants of up to £12,500 to invest in local recycling infrastructure to boost recycling facilities in their area.

Successful projects can spend funding on:

- The purchase of new bins and the adaption of old bins to fit the #InTheLoop principles (new vinyls, apertures etc.)
- Installation of bins
- Communication and engagement for the campaign
- Measurement and evaluation of the campaign.
- Staffing costs to cover the time spent planning and delivering the campaign

It is expected that most of the funding (75%) will go towards to the purchase on infrastructure on new bins or improvements to old bins (new vinyls, apertures etc.) The remaining amount should be spent on promotion of the campaign, and for measurement and evaluation of the project.

Projects must include the collection of plastic bottles and cans and could also include the collection of glass and coffee cups.

Successful applicants will also receive project management support, as well as assistance with project development and design.

The fund is open to applications from a wide range of organisations, including local authorities, Business Improvement Districts shopping centre owners and transport hubs such as airports, train and coach stations, etc.

Small community groups, local charities and individuals can apply for grants of between  $\pounds100$  and  $\pounds2,000$  for equipment and to support projects that tackle loneliness amongst older people (65+) and adults with a disability (18+).

- Contribution to immigration-related costs, where the current immigration status directly causes financial hardship to the applicant

### BlueSpark Foundation

Schools, colleges and community groups in England can apply for grants to BlueSpark Foundation to support the education and development of children and young people through educational, cultural, sporting and other projects.

BlueSpark is particularly keen to support projects which will help enhance the selfconfidence, team working skills and future employability of children and young people. In most cases, grants will be made on a relatively small scale.

The Foundation makes grants of up to £5,000. The majority of grants awarded however, are below £2,000.

The funding available can be for physical assets (such as iPads, sports equipment, or lighting for stage productions) or for services or facilities (such as sports coaching or music or drama tuition) or simply for the provision of experiences (such as theatre visits). These examples are intended to be illustrative and not restrictive as to the funding which BlueSpark may provide to support projects.

### Sport England - Small Grants Programme

Sport England has widened its Small Grants programme to provide support for projects that deliver environmental benefits for local communities.

The programme will not only provide funding to encourage greater participation in sport and physical activity, but it will also award grants of up to £15,000 for projects that benefit the environment.

This could include:

- Reducing energy use by installing energy meters or measures to improve insulation/ventilation to help reduce your energy usage; automatic controls to switch lights and electrical equipment off; using LED bulbs; or staging lower impact events and competitions.
- Encouraging responsible travel. This could include encouraging people to walk or cycle where possible and providing safe cycle/scooter/buggy storage options; promoting accessible and safe public transport routes and lift sharing; and using local community assets to minimise travel.
- Reducing waste and resource efficiency. This could include encouraging people to repair, recycle or re-use sports equipment or starting a kit and equipment donation scheme; offering more environmentally sustainable food and drinks packaging; reducing use of single-use plastics, for example by providing water-refill stations at your venue and encouraging participants to bring reusable bottles.

Eligible organisation that can apply include voluntary, community and social enterprise organisations, schools and local authorities.
