Erewash Voluntary Action CVS – Erewash Small Grant Scheme

The Erewash Small Grant Scheme is funded by Derbyshire County Council Public Health, Derbyshire County Council Adult Care Services and Erewash Borough Council.

Community groups and organisations can apply for up to £1,500.

The Erewash Small Grant Scheme has three priority themes and applicants must meet at least one of the themes to be eligible to apply. The priority themes include:

- Health Inequalities
- Community Wellness
- Building Resilience

Applications can be made by voluntary or community groups with a constitution, registered charity or charitable incorporated organisation, community interest company or social enterprise, other not for profit and parish councils.

The grant scheme is not open to statutory organisations.

It is an integral part of the application process that applicants can demonstrate their project is needed within the area, and that applications clearly demonstrate the benefits to the residents of the borough.

Erewash Borough Council – Members Grant Scheme

For the 2021/22 financial year, each Erewash councillor has £250 award to organisations within their ward (where applicable some Councillors will have an additional amount available to them as a result of carrying forward unallocated grant funding from 2020/21). It is for each councillor to determine which project(s) or organisation(s) they wish to support. The scheme allows a wide degree of flexibility in the type of project a councillor may support and the amount (minimum £50) they wish to allocate, subject to approval.

Activities that complement the council's draft core priorities:

- A safe, clean and welcoming borough
- Improved access to services
- Delivering efficient and effective services that residents need
- Creating opportunities for economic growth and prosperity
- A well run and efficient council
-

Organisations (including registered charities, community and voluntary groups, Community Interest Companies, Social Enterprises) within the councillor's own ward, or councillors may join together to support a project covering two (or more) wards.

- Councillors can allocate the entire £250 to one organisation, but where multiple organisations are to be awarded funding, there is a minimum award of £50 per organisation.
- Capital purchase items.
- Match funding for a project. Funding will be agreed but not allocated until the applicant confirms that all match funding is in place.

The scheme is administered by the council's Community Engagement Officer, colin.handley@erewash.gov.uk. However, organisations are advised that EBC Councillors are responsible for fully completing and signing grant application forms before they are submitted to the Community Engagement Officer.

Derbyshire County Council – Covid 19 Emergency Fund

The Public Health COVID-19 Fund was set up to support voluntary and community sector organisations to help manage and reduce the impact of the coronavirus pandemic on local communities. It also aims to help improve the health and wellbeing of local people.

Funding of up to a maximum value of £2,000 is available for constituted groups and £250 for non-constituted groups.

Applications must be linked to an existing Public Health programme, for example to support mental health and emotional wellbeing or to tackle social isolation.

Derbyshire County Council Members Community Leadership Scheme

Each County Councillor usually has £3,860 to give to local groups, this year an additional £3,860 has been allocated bringing their total to £7,720. Next year councillors will receive £3,860 plus £1,500 Platinum Fund to give local groups organising activities to celebrate the Queen's Platinum Jubilee.

Groups seeking funding should contact their local county councillor to explain the nature of the project, amount sought, what other funding is available and how it will benefit the community.

Severn Trent Community Fund – Maximising the Legacy

Severn Trent have partnered with Birmingham 2022 Commonwealth games as its official nature and carbon neutral supporter.

Sport England Queens Platinum Jubilee Activity Fund

The Sport England fund will commit up to £5 million focusing on the role of sport and physical activity in tackling inequalities and building stronger communities.

Sport England want organisations to consider how they could work more **collaboratively across their community**, in order to make the biggest possible impact.

Grants will be between £300 and £10,000, from a total pot of up to £5m.

Their priority is to support projects working with people in disadvantaged communities. Funds are available for project costs such as facility hire and coaching, as well as for small capital improvements.

Tackling Loneliness with Transport Fund

The Tackling Loneliness with Transport fund is now open for Expressions of Interest. DfT have received £5.8 million from Her Majesty's Treasury's Shared Outcomes Fund and are inviting proposals for pilot schemes that aim to tackle loneliness with transport.

The project will offer grant funding up to £500,000 to the public and charity sectors to run pilot transport schemes that aim to reduce loneliness. The pilots will be measured and evaluated rigorously, enabling DfT to:

Disabled children's holiday trust The Adamson Trust, after suspending activities due to Covid-19 is now accepting new applications for grants to support the cost of holidays or respite breaks for disabled children ages between 3 and 17 years of age.

The form asks for details of the holiday for which help with costs are being sought. You should say on the form how much the holiday will cost, where it will be, when and who will be going. If the holiday has already been booked, a copy of the booking confirmation should be sent with the completed form. If it is not possible to book the holiday until you know that the Trust will help, this should be stated on the form.

Individuals as well as groups, organisations and registered charities may apply.

The deadline for applications is at the beginning of February, May, August and November. Applications must be received by March 31 for the May meeting, by June 30 for the August meeting, and by September 30 for the November meeting.

The Veterans Foundation

The Veterans' Foundation grants programme supports charities and organisations that provide support to those in need among serving armed forces personnel, veterans, operationally qualified seafarers and their immediate families.

Projects which address any of the following will be considered homelessness, employability, poverty, disability, welfare issues, mental health, marriage guidance, care during old age and confidence building.

Grants available:

Grants up to £30,000 - Trustees will also consider a bid for a spread grant up to a maximum of £30K, i.e., £30K as £10K for each of the next two or three years.

Grants up to £40,000 – for exclusive use on salaries over a 2-year period i.e., £40K as £20K for each of the next two years.

There is a rolling programme with the following deadlines - 28 February for consideration in March and 20 May for consideration in June 2022.

Wallace and Gromit Children's Charity

Grants from £100 - £5,000 Grants must enrich and improve the quality of life of sick children in hospitals or hospices in any area in the UK.

Applications for funding must be from, or endorsed by, a children's hospital or hospice. They will not fund third parties who deliver services across multiple organisations without the support of the host hospitals/hospices. Preference is given to projects conceived by and developed in children's hospitals and hospices.

Grants will only be made to registered charities.

Projects can be any type which will improve the quality of life for sick children, but some examples given on the application guidance are:

- Arts, music, play and leisure programmes in a hospital or hospice setting.
- Facilities to support families of children treated in hospitals or hospices.
- Welcoming and accessible environments.
- Care and facilities in hospices.
- Promoting education and information programmes.
- Supporting children with physical and emotional difficulties
- Medical equipment (when it can be shown that funding is not available from statutory sources).

The deadline for applications is Friday 11th February 2022

Arts Council England – Let’s Create Platinum Jubilee Fund

Arts Council England has launched a new £5 million funding programme to support voluntary and community organisations in England to develop creative and cultural activities as part of the Queen’s Platinum Jubilee celebrations.

The Let’s Create Platinum Jubilee Fund will make grants of up to £10,000.

Applicants will be encouraged to think about what creative activity would mean the most to their local communities and why, and to partner with established artists, creatives and cultural organisations to develop their activities.

To be eligible projects should engage with at least one of the artforms which ACE supports through its funding. These are:

- Music
- Theatre
- Dance
- Visual arts
- Literature
- Combined arts - including festivals and carnivals
- Museum and library activities.

Schools are not eligible, but PTA groups can apply if they meet the eligibility guidelines.

The deadline for applications is 28 February 2022

VINCI UK Foundation

Charities and other not-for-profit organisations across the UK and Republic of Ireland can apply for grants of up to £20,000 for projects that improve access to employment, training, housing, mobility, or leisure for disadvantaged and socially excluded people.

The grants are being made through the VINCI UK Foundation and can be used to purchase, upgrade or refurbish transport, equipment, ICT, tools, furniture and facilities for long-lasting projects costing up to £100,000.

This could, for example, include the development of new/current activities, the refurbishment of premises, or the improvement of marketing tools.

Successful applicants will also receive the support of a VINCI sponsor, who will donate some of their time and practical expertise to the project.

National Lottery Heritage Fund

There are three grant fund opportunities to apply for heritage funding which include things from the past that are valued and can be passed on to future generations.

Projects are funded that connect people and communities to the national, regional and local heritage in the UK.

AB Charitable Trust

UK-registered charities that work towards combating abuse and violations of human rights can apply for grants of usually between £10,000 and £20,000 through the A B Charitable Trust. The A B Charitable Trust (ABCT) was set up in 1990 and supports unpopular causes that champion human dignity and to focus on small and medium-sized charities working close to the ground.

Applications are particularly welcomed from charities working to support:

- migrants and refugees
- criminal justice and penal reform
- human rights, particularly access to justice

The Trust generally makes one-off grants to charities registered and working in the UK with annual incomes of between £150,000 and £1.5m that do not have substantial investments or surpluses. Grants range in size, with most grants awarded being in the range £10,000 to £20,000. ABCT does not normally fund charities with large national or international links.

Your Best Friend Fund

Funding is available for not-for-profit organisations across England and Wales to deliver projects that provide women, girls and non-binary people the knowledge, confidence and tools to keep themselves and their friends safe in their dating relationships. Projects must increase understanding about healthy, unhealthy and toxic relationships and give young people confidence to keep themselves and friends safe.

There are large grants available with 6 – 8 grants of £10,000 - £25,000. Small grants with 30 – 40 available of £1,000 - £10,000

Small grants are accepted on a rolling basis.

Large grants deadlines are 18 February 2022 or 20 May 2022.

The Blakemore Foundation

The Blakemore Foundation offers two types of grants for community groups and charities within the company's trading area, which includes the East Midlands.

- In Kind Donations – donations in the form of goods to local community and charity events. Donations must be collected from Blakemore Retail SPAR stores or Philpotts stores. Applications are usually processed within 4 weeks.

National Heritage Memorial Fund (NHMF) - Covid-19 Response Fund

Public sector organisations, charities, voluntary groups, and other not-for-profit organisations can apply for a share of £40 million in funding to protect nationally important heritage which is at risk due to the impact of the Covid-19 pandemic.

The National Heritage Memorial Fund (NHMF) - Covid-19 Response Fund will allocate £20 million in funding to safeguard nationally important heritage assets within England such as:

- works of fine and decorative art
- museum collections
- archives
- manuscripts
- items of industrial, transport and maritime heritage
- historic buildings and land

This funding has been made available by the Department for Digital, Culture, Media and Sport through the Cultural Assets Fund to distribute alongside the NHMF's own commitment of £20 million to applicants across the UK.

Funding is available until the end of April 2023 and applications can be made at any time.

Crowdfunding and Continued Support from Sport England

Grants of up to £2,500 are available to charitable organisations supporting challenged and vulnerable young people under the age of 16 in the UK.

The 7stars Foundation will provide funding for projects which support young living in areas of deprivation and socioeconomic disadvantage who are challenged by abuse or addiction, who are young carers, or who are homeless. Projects should address a lack of provision and provide immediate support.

Example of support could include recreational trips, mentoring programmes, and counselling sessions.

Pets at Home Foundation - Pets Through People Grants

Grants are available for charities who provide temporary or ongoing assistance to ensure pets can remain with their owners, and/or change the lives of adults and children through the provision of animal-based activities.

The Pets through People grants aim to support charities in the UK that provide:

- Temporary ('foster') care to pets for reasons including, but not limited to, their owner entering sheltered accommodation, needing hospitalisation or escaping domestic abuse.
- Practical assistance to pet owners struggling to care for their pet due to their own ill-health, physical disability, or because they are homeless or vulnerably housed.
- Trained assistance animals to assist adults and children with disabilities to lead more independent lives.
- Animal-based therapy for vulnerable adults and children.

Grants of £250 to £50,000 are available. Larger grants may also be considered depending on the project. Multi-year funding applications, up to a three-year period, will be considered. The Foundation prioritises the funding of medium and small charitable organisations.

Pebble Grants – The Rank Foundation

The Rank Foundation has reopened applications for Pebble Grants which provide funding of between £250 and £4,000 to small UK registered charities and recognised churches which are raising money for projects where the total cost is less than £150,000.

The project must be for the benefit of UK residents, including but not limited to citizens, long-term residents and asylum seekers. Funding can be used for either: capital costs, such as funding for fixed, one-time expenses incurred on the purchase of land, building work, refurbishment, and equipment; or short breaks where funding is targeted towards annual respite breaks for disadvantaged young people, and short-term activities or programmes.

Applicants must have already raised a third of the total costs.

Pebble grants are awarded on a rolling basis.

The Henry Smith Charity

The Henry Smith Foundation provides grants of between £20,000 and £60,000 per year for up to three years to charitable organisations (charities and not-for-profit organisations, including social enterprises) that help people when other sources of support have failed, are inappropriate, or are simply not available.

The charity has six funding priorities that describe the work they support and how they want to bring about change for the most disadvantaged people in the greatest need. These are:

- Help at a critical moment - Helping people to rebuild their lives following a crisis, critical moment, trauma or abuse.
- Positive choices - Helping people, whose actions or behaviours have led to negative consequences for themselves and others, to make positive choices.
- Accommodation / housing support - Enabling people to work towards or maintain accommodation.
- Employment and training - Supporting people to move towards or gain employment.
- Financial inclusion, rights and entitlements - Supporting people to overcome their financial problems and ensure that they are able to claim their rights and entitlements.
- Support networks and family - Working with people to develop improved support networks and family relationships.

Grants can cover running costs, salaries and project costs for organisations that can demonstrate a track record of success and evidence the effectiveness of their work. Eligible organisations include charities and not-for-profit organisations (including social enterprises) in the UK with a turnover of £20,000 - £500,000.
