Derbyshire County Council - Warm and Welcoming Spaces Grants

Voluntary, community and charity organisations in Derbyshire can apply for a grant to set up warm and welcoming spaces this winter.

Derbyshire County Council have launched a warm and welcoming spaces fund to support organisations to provide a warm refuge for residents and their families struggling to heat their homes.

Organisations can apply for up to £1,000 towards the cost of opening up community venues or to extend their opening hours during the colder months.

The amount of grant funding awarded will be determined following assessment of eligibility criteria, consideration of the amount of hours that the warm and welcoming space will be open (especially at evenings and weekends), and the number of potential beneficiaries.

Applications will be accepted up to **1 March 2024**, or until the funding allocated to the programme has been fully spent (whichever is sooner).

To qualify for a grant, organisations must pledge to offer a heated space during the winter months, provide seating, offer refreshments such as a warm drink and a biscuit, and be free of charge.

If you are an organisation or charity that's running a warm and welcoming space, register your venue with the **Warm Welcome Spaces Campaign** so residents can find you.

<u>Severn Trent Community Fund - Core Funding – Now Open</u>

This core funding is for groups that run for the benefit of local residents, supporting those most vulnerable, who need urgent financial help to maintain their services.

Groups can apply to be considered for a restricted grant of between \pounds 5,000 - \pounds 20,000 (depending on the size of the organisation) for 1 year to help them and our communities get through this incredibly challenging time.

This support will be available to not-for-profit organisations that:

- run for the benefit of local residents within the Severn Trent region, supporting those most vulnerable.
- have been operating since **2018 or before**.
- have an annual income of £250,000 or less (averaged over the past 5 years).

Sports clubs, cadets, Girl Guides and Scouts are not eligible for this funding stream.

Open for applications now

Severn Trent Community Fund: Core Funding will be open from Monday 13th November until midnight on Sunday 10th December. We expect demand for this support to be high, unfortunately we will not be able to fund every application we receive.

Whilst Severn Trent will not be awarding applications for new projects during this time, new project applications can still be submitted to us. We'll continue internally reviewing applications however the next opportunity to be considered for award will be from March 2024 for applications of over £10,000 and May 2024 for applications of £2,000 - £10,000.

<u>Erewash Voluntary Action CVS – Erewash Small Grant</u> <u>Scheme</u>

Derbyshire County Council Public Health, Derbyshire County Council Adult Care Services and Erewash Borough Council fund the Erewash Small Grant Scheme.

Community groups and organisations can apply for up to £1,500.

The Erewash Small Grant Scheme has three priority themes and applicants must meet at least one of the themes to be eligible to apply. The priority themes include:

- Health Inequalities
- Community Wellness
- Building Resilience

Applications can be made by voluntary or community groups with a constitution, registered charity or charitable incorporated organisation, community interest company or social enterprise and other not for profit organisations.

The grant scheme is not open to statutory organisations. From 1 August 2023 this includes Parish Councils.

<u>Erewash Borough Council – Fast Funding Community</u> <u>Grants</u>

The council has received Shared Prosperity Funding (SPF) from central government, to support its revised Fast Funding Community Grant scheme. Qualifying community organisations, including registered charities, voluntary organisations and social enterprises, are invited to apply for a grant of up to £1,500 to deliver a project or activity that will provide benefits for Erewash residents.

All applications must show how their project or activity will achieve one or both of the Fast-Funding Community Grant scheme's outcomes:

- Increased engagement (of at least 10%).
- Increased volunteering (of at least 10%).

Derbyshire County Council Public Health Covid Community Fund 2023-2024

The COVID-19 Community Fund aims to support voluntary and community sector organisations by providing much needed funding. This allows them to continue to play a key role in the local response to COVID-19 and to improve the health and wellbeing of Derbyshire residents.

The funding is for organisations and projects that meets at least one of the criteria below:

- support to increase COVID-19 vaccination uptake
- protect people most vulnerable to COVID-19
- increase mental health and wellbeing and support individual and community resilience
- promote safer behaviours to reduce future risk of infection
- directly address health inequalities arising from, or made worse, by the pandemic

Constituted organisations and groups can apply for up to £2,000 in funding, and nonconstituted organisations and groups up to £250.

If you have previously received a grant from the COVID-19 Community Fund, you are eligible to reapply. However, the second application must not be a duplication of the original request. an Organisations could re-submit an application that has previously been rejected if it meets the new criteria.

The fund closes on 31 March 2024 applicants are advised to apply early.

Derbyshire County Council Members Community Leadership Scheme

Each County Councillor usually has £3,860 to give to local groups, this year an additional £3,860 has been allocated bringing their total to £7,720.

All 64 of our councillors get funding through the members' Community Leadership Scheme to give to communities and organisations in their area.

Groups seeking funding should contact their local county councillor to explain the nature of the project, amount sought, what other funding is available and how it will benefit the community.

National Lottery Community Fund - Awards for All England

Voluntary, community organisations and Schools, etc across the UK can now apply for grants of up to £20,000 from the National Lottery Community Fund – Awards for

All programme. This represents a significant increase from the previous maximum grant size of £10,000. Projects can last for up to two years.

The funding boost is intended to support organisations in delivering new or existing community led activities. Eligible projects must achieve at least one of the following objectives:

- Bring people together to build strong relationships within and across communities
- Improve places and spaces that matter to communities
- Help individuals reach their potential by providing early support
- Assist individuals, communities, and organisations facing difficulties due to the cost-of-living crisis

Organisations eligible to apply include:

- Constituted voluntary or community organisations
- Constituted groups or clubs
- Registered charities
- Charitable incorporated organisations (CIOs)
- Not-for-profit companies
- Community interest companies (CICs)
- Schools (provided the project benefits and involves the surrounding communities)
- Statutory bodies (including local authorities, town, parish, and community councils)
- Community benefit societies

The application deadline is 16 weeks before the start of the project or activities.

School for Social Entrepreneurs

Cost of Living Challenge Fund 2023 SSE's Cost of Living Challenge Fund offers support to charities and social enterprises serving the most disadvantaged communities in England who are struggling most with the cost-of-living crisis– for example, those that are providing food, energy saving and warm spaces, access to essential goods, financial advice, essential transport, mental health support and access to housing.

What's on offer

- A Match Trading[™] grant of up to £25,000, with the possibility of rapid drawdown and further funds for exceptional performance. •
- Capacity building support to help build your organisation's resilience and sustainability and support you to build up enterprise activity to meet increased demand.

Who is eligible to apply? We are looking to support organisations based in England working in disadvantaged communities that are providing the following services to support people facing crisis due to the increased cost of living: Your organisation must provide services to support people facing crisis due to the increased cost of living. This might include:

- Food e.g., Community shops, pay-as-you-feel cafes, supply of fresh produce, holiday and breakfast clubs etc.
- Energy saving and warm spaces provision of warm spaces, provision of energy saving advice and support, access to home improvements etc.
- Access to essential goods clothing, furniture, goods for children and babies
- Financial advice welfare and benefits advice, support with utilities, credit union development, access to low-cost loans.

John Ellerman Foundation – Museums and Galleries Fund

The Museums and Galleries Fund aims to help strengthen museums and galleries in the UK, celebrating the unique assets that our regions possess and their benefit to us nationally. We want to help organisations enhance and sustain curatorial development to attract a broader and more diverse public. We have earmarked 10 per cent of our overall grants budget for the 2024/25 financial year to be awarded through the Fund, with final decisions made in May 2024 for this round.

We generally expect to make five or six grants for periods of two to three years. While the average grant size is circa £90k we will consider higher amounts for exceptional projects.

What we will fund - We are keen to fund work which has a legacy within and beyond the organisation. We prioritise applications that aspire to achieve outcomes for

people working in curatorial roles, the collections they work with and the institutions in which they work.

We are particularly interested in proposals which:

- enable new ways of working through innovation, new thinking and fresh approaches both for established curators or those just starting out and/or •
- ensure organisations are able to safeguard and advance curatorial skills and conservation skills and make the most of opportunities at a time of development or change.

Who can apply - The Fund is open to a wide variety of collection types. We have supported visual and decorative arts, social history and anthropology, science and technology, industrial, natural history collections. In line with our general policy, we favour organisations with an income between £100,000 and £10m but may fund a larger institution if it is uniquely placed to meet our aim.

Local authority, independent museums and contemporary galleries without permanent collections are also eligible.

First-stage applications must be received by 5pm on Monday 8th January 2024.

LoveReading4Kids - Funding for Schools Scheme

UK schools and early years' settings can apply for grants of between £1,000 and £5,000 to buy books for their libraries and encourage more children to read for pleasure.

The LoveReading4Kids Funding for Schools Scheme will help schools to provide children with a range of non-curriculum books to improve their reading standards, particularly amongst children experiencing disadvantage or underrepresentation.

Areas for Consideration will include:

- Schools with income deprivation or cultural deprivation
- FSM
- IDACI
- Literacy levels
- Schools looking to improve standards

Any grant awarded will be made in the form of credit to be spent within six months on the LoveReading4Kids online bookstore.

Applications can be submitted at any time, with decisions taking up to three months.

<u>Department for Levelling Up, Housing and Communities -</u> <u>Windrush Day Grant Scheme</u>

The government has announced that £500,000 in funding is available for local communities in England and Northern Ireland to hold events celebrating the Windrush Generation and their positive impact on modern Britain.

Charities, community groups, and councils can apply for grants to fund parades, educational resources, arts and sporting projects. Proposals should clearly demonstrate how their project will work with local community partners. These might include but are not limited to organisations such as museums, libraries and schools.

The minimum amount available for each project is £5,000 and the maximum is £50,000. This year, there are 2 tiers of funding:

- Tier 1: smaller projects, of a value between £5,000 and £24,999
- Tier 2: larger projects, of a value between £25,000 and £50,000

The funding is being made available through the Windrush Day Grant Scheme, which is administered by the Department for Levelling Up, Housing and Communities.

Applications from outside Greater London and the South East are encouraged.

Consortium bids will also be accepted.

Applications must be submitted by 11:59pm on the 17 December 2023.

The Elephant Trust

The Trust offers grants to artists and for new, innovative visual arts projects. It aims to make it possible for artists and those presenting their work to undertake and complete projects when confronted by a lack of funds. The Trust supports projects that develop and improve the knowledge, understanding and appreciation of the fine arts.

Priority is given to artists and small organisations and galleries making or producing new work or exhibitions. The Trust normally awards grants of up to £2,000, but larger grants of up to £5,000 may be considered.

Aviva - Community Fund

Organisations seeking to raise up to £50,000 with innovative ideas that benefit their communities now have an opportunity to apply for funding through Aviva's Community Fund initiative. Aviva has partnered with the fundraising platform Crowdfunder to offer this funding to small charities, schools, and community interest groups in the UK. Eligible causes can apply for funding at any time.

Aviva is looking to support projects that boost community resilience in the face of uncertainty, with a focus on two key areas:

- Climate Action focuses on promoting healthy and thriving communities by preventing, preparing for, and protecting against the impacts of climate change.
- Financial Wellbeing aims to help people take control of their wellbeing by providing them with tools to become more financially resilient and independent.

To participate, the project must also be raising funds to develop a new approach, product or technology, pilot a new scheme, implement a new initiative, or expand existing services to a new area or beneficiary group. All beneficiaries must be based in the UK.

Once applications are submitted, applicants will need to create a fundraising page on Crowdfunder, which Aviva employees and the public can browse and donate funds to.

Big Give Green Match Fund

The Big Give Green Match Fund is now accepting applications from environmental charities seeking match funding of up to $\pounds 100,000$ to support their projects. As the world's first and largest online match funding platform, the Big Give has raised over $\pounds 100$ million for over 1,000 projects since its inception in 2007.

This match funding opportunity doubles every pound raised by eligible environmental charities, up to a maximum of £100,000. The funding can be utilised for a wide range of environmental initiatives, including tree planting, wildlife habitat creation, pollution reduction, and sustainable energy promotion.

To qualify for the Big Give Green Match Fund, charities must be registered with the Charity Commission in England and Wales or Scotland and have an annual income of at least £25,000. Additionally, applicants must be working on a project that demonstrably benefits the environment.

Two match funding models are available:

- 1. **1:1 Model:** Up to £10,000 in public donations will be matched pound for pound by the Big Give.
- 2. **Pledge Model:** Up to £100,000 in public donations will be matched pound for pound by the Big Give. Eligible charities can also receive up to £50,000 in Champion funds.

Help the Homeless

Help the Homeless makes grants of up to £5,000 to small charitable organisations with a turnover of less than £500,000, whose aim is to help homeless people return to the community and enabling them to rebuild their lives.

Typically, such organisations may operate residential or training facilities to assist homeless people.

The closing date for the next round of funding is the 15 December 2023.

The Seven Friends Foundation

Provides small grants up to £3,000 to organisations that fulfil their charitable aims:

- To support and promote causes that are ignored, unpopular or face widespread stigma
- Create stronger local communities that include those who have previously been excluded or marginalised
- Improve skills, infrastructure, sustainability and collaboration within the third sector.

The foundation will support small organisations, typically meaning those with an average annual income of under £300,000.

Grants are available to both registered charities and other organisations which are not charities but which seek funding for charitable work, however, these organisations may be asked to provide additional evidence.

The foundation will support organisations working anywhere within the UK but has a preference for those located in areas of deprivation.

These types of causes and groups that may receive funding include:

- Asylum seekers and refugee
- Migrant communities
- Offenders and ex-offenders
- People experiencing violence or abuse.

The deadline for applications is 1February 2024.

Love Rowing

Grants are available to support rowing clubs, community organisations, schools and charities that are working to get more people involved in rowing and make the sport more accessible.

The funding is being made available through Love Rowing, British Rowing's Charitable Foundation, which aims to support organisations to make rowing more inclusive, create better awareness around the benefits of the sport, and to reach new and diverse communities across the UK.

Preference is given to activities focused on

- Young people from low socio-economic backgrounds
- People from ethnic minority backgrounds
- People with a disability or long-term health condition

The grants can be used to help purchase equipment for the target audience listed above, i.e., adaptive equipment, ergos for schools.

VocTech Trust - Activate 2024 Grant Programme

The VocTech Trust, which is a charity that supports the use of technology to improve adult learning and skills. Through the fund, a total of £900,000 will be available to support the development of early-stage digital tools and approaches with the potential to tackle vocational learning problems and get adults learning. Individuals, organisations, and partnerships that have an idea for a new digital tool or approach to vocational learning can apply for the grant.

Grants of between £30,000 and £60,000 are available for projects lasting up to 12 months. The grant can be used to develop and test new digital tools and approaches to vocational learning. This could include developing prototypes, conducting user testing, and evaluating the effectiveness of the new tool or approach.

The VocTech Activate grant fund is part of the Ufi VocTech Trust's commitment to supporting the development of innovative solutions to vocational learning challenges.

The fund is particularly interested in ideas that have the potential to transform how vocational learning happens, rooted in a real-world understanding of the problems, issues and opportunities in the vocational sector.

All applicants are encouraged to attend a grant workshop before applying to the fund. The online workshops provide an opportunity to find out more about the fund.

Hubbub - Nature Hubs Fund

Community, groups, schools and other not for profit organisations in England, Scotland, and Wales have the opportunity to apply for grants of up to £6,000 to create new green spaces or to improve existing ones. The grants are being offered by the environmental charity Hubbub in partnership with Starbucks.

50 grants are available.

The Nature Hubs Fund is part of Hubbub and Starbucks' wider ambition to build stronger, greener communities across the UK. This fund will improve access and connection to nature in the communities Starbucks serves, by creating green spaces within a 5km radius of Starbucks stores.

UK registered charities and not-for-profit organisations seeking financial assistance for their projects can apply for funding from the Charles Hayward Foundation. The foundation offers two types of grants: main grants and small grants.

The main grant applications are considered four times a year – in February, May, July, and November – offering a structured timeline for applicants. The small grants, on the other hand, are reviewed on a rolling basis, providing more flexibility for those in need of quicker funding solutions. However, it is important to note that the small grant programme is currently closed to new applications and is set to reopen in January 2024 with revised guidelines and funding priorities.

The grants provided by the Foundation are designed to support projects across various sectors, including:

- heritage and conservation,
- criminal justice,
- older people,
- overseas aid.

Canoe Foundation

The Canoe Foundation provides grants of between £500 to £10,000 to promote new or improved access points for canoe trails on to moving water, estuaries, canals and reservoirs.

Phoenix Way: Children and Youth Round

Grants of between £30,000 and £50,000 are available to charities and other not-forprofit organisations in England and Wales that are working to support Black and ethnically minoritised children and young people that are at high risk of becoming involved in violence.

A total of £2 million in funding is available through the Phoenix Way: Children and Youth Round to support projects aimed at:

- diverting children and young people from crime
- providing supportive home environments
- improving education

The grants awarded under these programmes will enable homes for veterans with a housing need to be brought up to date through a refurbishment grant or will support organisations with the early-stage development of more complex building projects.

Refurbishing existing Veteran's housing – The Refurbishment Grants Programme will award grants of up to £75,000 for projects that will refurbish or extend existing accommodation for veterans. This could be transitional or permanent housing. Permanent housing can only include properties that are available to veterans under a social rent or are part of a wider facility that provides a rented home to a veteran with the tailored support that meets their needs (this can include care homes).

You can apply to this programme if your project will:

- enable refurbishments of existing affordable homes for rent to veterans
- enable refurbishments of sites that increase the availability of veteran housing
- ensure properties meet decent homes and energy efficiency standards.

• Help with development costs -

The Development Grants Programme can help if you would like to apply for costs of getting a building idea to provide new housing for veterans to the stage where on site works could start. Grants of up to £25,000 are available for projects lasting up to one year. You can apply to this programme if:

- Your project is at an early stage of development; and
- You require funding for professional support costs such as architects, qualified construction project managers or quantity surveyors, to develop detailed building plans and cost assessments for projects that would provide additional capacity in services for veterans who are at risk of homelessness.

This is a development grant programme – grants cannot be used for direct capital costs to create or refurbish buildings.

Eligible organisation that can apply include voluntary, community and social enterprise organisations, schools and local authorities.

- People with perceived barriers to cycling.

Funding can be used for costs including but not limited to:

- Staff costs.
- Volunteer expenses, such as refreshments and travel.
- Equipment purchases, including tools, bikes, bike parking, locks, helmets, high-vis jackets, and pumps.

- Equipment hiring, such as cones, high-vis jackets, helmets, or bikes.
- Consumables, including brake pads, inner tubes, cables, lubricant, or small parts.
- Venue hires or location fees.
- Participant refreshments such as reasonable drinks and snacks.
- Promotion costs.
- Transport, including transportation of goods to and from the event location.
- Personal Protection Equipment.

Funding is for events delivered between 4 November 2023 and 25 February 2024. Groups are expected to deliver around eight events.
