## **New Funding Opportunities**

## Funding for Projects that Make it Easier to Talk About Death & Dying

Funding is available to support innovative community arts and culture projects that open up conversations about dying, death and grief in new and creative ways. Hospice UK's Dying Matters Community Grants Programme will award grants of between £5,000 and £10,000 to hospices for community-led projects that support hard to reach groups including:

- ethnic minorities, homeless people, prisoners
- people with learning disabilities
- · LGBT+ people
- those living in remote and rural areas
- people living in poverty, deprivation and with lower socioeconomic status

#### Funding can be used to cover:

- artist fees, facilitator costs, exhibition / installation costs
- materials, craft materials, translation & marketing
- refreshments, venue hire, sound and light

#### Applications close at 5pm on 5 December 2025

# **Grants to Tackle Barriers for Disabled Passengers**

The National Centre for Accessible Transport (ncat), a UK initiative dedicated to making transport accessible for disabled people has opened applications for its 2025–26 Scaling Innovation Programme. The programme offers funding and support for projects that tackle key barriers faced by disabled passengers. The scheme aims to build a barrier-free transport system by combining research, technical expertise, and the lived experiences of disabled people.

This round invites proposals addressing three core challenges:

- accessible vehicles stop design,
- improved travel assistance services,
- and better access to live travel information.

Applicants must demonstrate meaningful involvement of people with disabilities throughout their project, which carries the highest weighting in the assessment process.

The competition is open to UK-registered organisations of any size, including academia, research and technology organisations, charities, industry, and local or central government.

Applications close on 7 November 2025, with interviews scheduled for early 2026.

## **The Schroder Charity Trust Grants Programme**

The Trust are only considering applications for work under the following two objectives:

- Objective (1): Enabling children and young adults from disadvantaged backgrounds to thrive and achieve their potential in education and employment
- Objective (2): Strengthening communities through services and opportunities which enhance the wellbeing and life outcomes of vulnerable and disadvantaged people

Grants of up to £5,000 are typically awarded, and funding may be used towards either core or project costs. Applications will be accepted from UK-registered charities with an annual income between £150,000 and £1 million.

## **Applications for Funding Towards School Trips to CERN**

The Ogden Trust, which promotes the teaching and learning of physics, has announced that secondary schools that are or have been members of its School Partnerships programme can apply for grants of up to £2,500 for trips to the CERN, the European Organisation for Nuclear Research. This will be the final round of funding available on this programme.

These grants aim to allow disadvantaged students to experience one of the world's foremost centres for scientific research and to learn about the physics research that is taking place at CERN, as well as meet some of the physicists who work there.

Students participating in the programme must be eligible for pupil premium, the 16-19 bursary, or be a scholarship pupil at an independent school.

The closing date for applications is the 14th of November 2025.

# **Grants Available to Expand Nursery Education Provision**

The Department for Education is offering up to £150,000 to eligible state-funded primary-phase and maintained nursery schools in England to create or expand nursery provision.

The objective is to boost early years capacity, improve access for disadvantaged families, and ensure high-quality provision supports children's school readiness without displacing existing local services.

Funding can be used to create or repurpose spaces for nursery classes within primary schools, expand nursery classes in maintained nurseries, or support nursery units run by governors, academy trusts, or contracted providers.

Projects must deliver a net increase in childcare places and be operational before September 2027.

Schools that received funding in phase one, Special Schools, and Pupil Referral Units are not eligible for this round. Applications require local authority approval and landowner permission, with successful applicants notified in April 2026.

Applications close on 11 December 2025.

## Grants up to £1,000 to Support Local Good Causes

Community groups across the UK can now apply for grants of up to £1,000 through The Co-operative Bank's Customer Donation Fund. The scheme, which supports grassroots initiatives, is open to organisations with a Co-operative Bank Charity or Community Directplus account.

Grants are awarded four times a year and can be used for a wide range of purposes, including buying equipment, hiring venues, running community events, or supporting outreach work. The fund is designed to help small charities and community groups deliver local projects that bring people together and create lasting social impact.

To apply, organisations must show how their proposed activity will benefit the local community and demonstrate clear outcomes.

Applications are assessed on community benefit, need, and impact.

Applications received from 1st October 2025 to 31st March 2026 will be assessed in April 2026.

## **Funding to Improve Online Digital Presence for Small Charities**

UK-registered charities can apply for funding of up to £2,500 to improve their online digital presence. The Fat Beehive Foundation awards small grants to charities with an average income of less than £1,000,000 yearly to support hard-to-fund digital expenditures that other funders often do not cover.

Funding will help organisations to build websites and apps, digitise services, and purchase digital products. Trustees are particularly keen to support traditionally hard-to-fund organisations, such as those supporting prisoners, refugees, or disadvantaged youth.

**Applications can be submitted at any time** and are reviewed at trustee meetings in April and October. The deadline for applications is the end of September for the October meeting and the end of March for the April meeting. **The closing date for the next round of applications is 31 March 2026.**

National Lottery Project Grants are open for applications. You can now apply for either £30,000 and under, or for £30,001-£100,000. These strands are both the same as they were before. NLPG Major Projects, Place Partnerships, and Touring strands reopened for application in mid-October.

## New Government Fund Announced to Support Community Cohesion

Voluntary, community, and social enterprise (VCSE) organisations in England are set to benefit from a new £1.7 million government initiative aimed at strengthening community cohesion and resilience. Organisations will be able to access capital funding of up to £10,000, with higher awards offered in exceptional cases. The Fund aims to:

- identify and reward good practice in building bridging social capital
- invest in the physical spaces and equipment that enables good practice
- build a community of practice, for knowledge sharing across the voluntary and community sector and with government

Capital grants can be used to support new builds, refurbishment, and expansion of facilities used to build bridging social capital. Funding can also cover essential equipment, such as laptops or furniture for the property.

In addition to funding, successful applicants will join a wider community of practice, fostering collaboration, knowledge exchange, and long-term social resilience.

Applications must state the level of funding required, that can be committed for spending by the 31st March 2026.

The fund closes on the 21st of November 2025.

## Severn Trent Community Fund – Core Funding is opening 1st November

Core Funding will be open for applications from Saturday 1st November to Sunday 30th November 2025. Eligible not-for-profit organisations can apply for a restricted grant of £5,000–£20,000 to support their core costs for one year. Around 28 organisations from across the Severn Trent region [check the <u>map</u> or <u>postcode</u>] are expected to be funded in this round.

This core funding is for groups that offer essential services to local residents, especially those supporting the most vulnerable – helping to improve wider community wellbeing. The aim is to help groups who urgently need financial support to continue existing delivery.

## **Student Opportunities in Public Museums & galleries**

Funding is available to help public museums, galleries, historic houses, libraries, and visual arts organisations in the UK to provide meaningful paid work experience opportunities for full-time university students that enable them to explore further their interest in the arts and related future career options before they graduate.

Through Art Fund's Student Opportunities programme, organisations can apply for up to £10,000 towards the costs associated with paying students for their time to help deliver projects.

Art Fund will consider 100% funding towards the costs. Applicants should allow at least eight weeks between submitting applications and when they need a decision.

The next closing date for applications is 16 January 2026.

# **Grants for Environmental and Social Wellbeing Projects**

Registered charities are invited to apply for grants that support projects delivering positive environmental, social, or wellbeing outcomes for communities throughout the country.

This funding comes from the Calisen Impact Charitable Trust, which is dedicated to fostering economic and social development by backing initiatives that focus on at least one of the following goals:

- Helping the UK achieve its climate targets
- Moving the UK towards zero emissions
- Creating a more sustainable energy system
- Promoting inclusion and building safe, diverse educational and working environments
- Supporting economic and social growth in communities where Calisen operates, particularly in the Northwest and across the UK

Previous projects supported by the Trust include Eco-Schools, which helps schools earn Green Flag accreditation and engages children in environmental action, and Youth Zones, which provide nutritious meals and support for disadvantaged young people.

## **Funding to Support Arts, Library & Museum projects**

Arts Council England's National Lottery Project Grants programme has reopened for applications to the **'£30,000 and under'** strand, supporting arts, library, and museum projects. The programme aims to support individual artists, community and cultural organisations to create and sustain high-quality work and help more people across England to engage with arts and culture.

Funding is available for projects lasting up to three years that are focused on one or more of the following disciplines:

- Combined arts (including festivals and carnivals)
- Dance, Music
- Libraries (for activity that delivers against at least one of the four Universal Library Offers)
- Literature
- Museums and collections
- Theatre, Visual arts

Applicants should note that whilst the guidance and application questions remain unchanged, applications will now be made via a new platform. Support documents are available to guide applicants through the process.

Applications can be made at any time, with decisions expected within ten weeks of submission.

# **Erewash Borough Council Community Grants**

The council has two Community Grant Schemes for 2025-26 and they are now open for local community and voluntary groups to apply for. Many groups in Erewash have benefitted from community grants provided by the council over previous years, including sports groups, arts groups, and lots of others.

The council is working towards 'creating vibrant and sustainable communities' as outlined in its Corporate Strategy 2024-2028. Grant applications are invited from projects or activities which will support at least one of the following priorities:

- Economy and Regeneration work to rejuvenate the economy.
- Supporting communities to be active, healthy, and safe.
- Sustainable environment create an environment for the future.

The council's two community grant schemes are:

- Fast Funding Grants for awards of between £500 and £1,500.
- Member Grants for awards of between £2,000 and £3,500.

Subject to the availability of funding, both schemes will remain open until 28 February 2026.

## **Funding to Tackle Inequalities in Creative Education and Employment**

Youth Music has launched a £2.25 million initiative to tackle barriers facing disabled children and young people in the arts. The new *Shift the Scene Fund* will support long-term, community-based creative programmes—across music and other art forms—designed by and with disabled young people aged 9 to 30. Funding may include paid employment, bursaries, or micro-grants.

The fund is open to established organisations in England already working inclusively with d/Deaf, Disabled, or Neurodivergent young people.

## Eligible projects must be:

Long-term: running three to four years, not short-term or one-off.

Community-based: rooted in and responsive to local needs.

Multi-disciplinary: spanning music, theatre, dance, visual arts, film, digital, or cross-arts approaches.

Co-created: shaped and led with Disabled young people at every stage.

Progression-focused: offering sustained opportunities, such as 1:1 support, mentoring, and career pathways. Inclusive: embedding the social model of disability, anti-ableist practice, and accessible design.

Applicants must show a proven track record in anti-ableist practice, amplify young Disabled voices, and embed inclusion, diversity, equity, and access across their work.

Guidance will be published on 1 October 2025, with applications open from 31 October to 28 November 2025. Successful applicants will be announced on 27 March 2026.

## **Funding to Improve the Sustainability of Community Sports Clubs**

To ensure more people have access to local sports, the Cash4Clubs grant programme is making grants of £2,000 available to support the sustainability of community sports clubs and organisations throughout the UK.

The programme offers community groups the opportunity to access unrestricted funding to improve facilities, buy new equipment, gain coaching qualifications and invest in the sustainability of their club. A total of £500,000 is available in this funding round.

Applicants must solely be delivering activities to adults (18+) to be eligible for funding.

Costs that can be funded included:

- venue hire including floodlights / heating
- coaching costs
- volunteer expenses
- equipment
- kit
- marketing and communications
- training and qualifications
- insurances and affiliations

Applications are particularly welcomed from clubs targeting communities from deprived areas, as well as those using sport for other social purposes such as targeting underrepresented groups, developing skills, reducing crime or addressing anti-social behaviour.

The closing date for applications is 8 December 2025.

## **Funding for Rural Community and Education Projects**

The NFU Mutual Charitable Trust offers grants for initiatives that support charities in the UK working in agriculture and rural development. The Trustees are particularly interested in initiatives that meet the following criteria:

- Advance the education of the public using research and dissemination of information about agriculture, a key area of interest for the Trustees.
- Advance the education of young people within rural areas
- Relieve poverty within rural areas
- Promote the benefit and social welfare of rural community inhabitants by associating with the inhabitants and local authorities, voluntary and other organisations to advance education and leisure.
- Promote research into agriculture-associated activities
- Advance the education of the public using research and dissemination of information in relation to insurance provided that the charity may also promote, facilitate and support any such other purposes as are exclusively charitable according to the laws of England and Wales

Grants range from £1,000 to £ 50,000. Larger donations are specifically aimed at supporting organisations that have a significant impact on rural communities at a national level.

## **Funding to Help Vulnerable People with their Housing Needs**

## **Funding for Leisure Activities for Children with Additional Needs**

The Happy Days Children's Charity is inviting applications for funding towards trips, respite breaks and group activity holidays for disadvantaged children and young people with additional needs.

The charity awards funding for different types of activities to support families with children aged 3-17 who have a disability, a special need or have been abused.

Grants are available for the following activities:

- Family Day Trips eligible trips include zoos, farm parks, theme parks, the seaside or the theatre
- Family Holiday Breaks a short break family holiday by the seaside or in the countryside, usually in the United Kingdom. Other destinations will be considered according to cost.
- Group Day Trips and Visiting Theatre a day trip to a wide variety of destinations, for example, the seaside, a theme park, the theatre, or for a theatre workshop to visit the applicants' premises. Items that can be funded are tickets/passes and transport costs
- Group Activity Holidays a group activity holiday to a wide variety of destinations such as outdoor activity centres, holiday camps and sailing breaks

Applications for family activities are accepted from parents, guardians, grandparents or siblings, as well as GPs, consultants, nurses or social workers.

Applications for group activities are accepted from organisations such as SEN schools and groups, young carers and women's refuges.

## **Grants up to £5Million for Projects Addressing Inequality**

The National Lottery Community Fund has launched the Solidarity Fund to support charities and not-for-profit organisations in England that address the causes of inequality, including poverty, disadvantage, and discrimination. Organisations can apply for grants ranging from £1 million to £5 million for projects lasting between 5 and 10 years.

To be eligible, organisations must be led by, and accountable to, people with lived experience of the issues you're trying to change.

## Eligible costs may include:

- Staff costs, including sessional workers
- Development work (e.g. staff training, governance, IT upgrades, and sharing learning)
- Transport, Utilities and running costs
- Volunteer expenses
- Learning and evaluation, Equipment
- Minor capital costs for land or building work (these should not form a significant portion of the funding request)
- Translation and interpretation costs for non-English speakers

There is no closing date; applications can be submitted at any time.

## **The Classical Association Grants**

Grants are available to support classical projects in the UK. The funding is being made available through the Classical Association. The Classical Association is an educational charity that makes classical subjects widely accessible. The grants typically fund activities undertaken by schoolteachers, students, academics and organisations with the aims of:

- Supporting the teaching and learning of classical subjects and topics, primarily in UK schools but also amongst the wider public;
- Increasing access to classics, widening participation and pursuing EDI objectives in UK classics;
- Increasing the sustainability and viability of classics as a discipline in UK schools and beyond.

Applications for small grants of up to £4,999 should be submitted by the following deadlines: 1 March, 1 June, 1 September, 1 December.

## **Grants for Early-Stage Ideas Driving Social Change**

Grants of up to £20,000 will soon be available to support individuals, groups, and small organisations in the UK who want to explore new ideas for social change or challenge how things are currently done—before there's a proven model or track record.

The Paul Hamlyn Foundation's Ideas and Pioneers Fund provides funding and tailored support to help early-stage innovators test, research, and develop new approaches with the potential for long-term impact. Applications will be accepted from:

- Individuals (aged 18 years or over). Preference is for people between the ages of 18 and 30 years.
- Small groups of up to three people.
- Small organisations with up to five employees.

The Foundation is particularly keen to welcome first time applicants, and those most affected by systemic oppression and/or discrimination (for example: tackling racism, ableism, classism, sexism, xenophobia, homophobia or transphobia),

Examples of activities that could be funded include:

- Developing a product or new approach.
- Gathering evidence for a campaign.
- Paying yourself or others to deliver the activities being applied for.
- · Research to develop your idea, and
- Talking to people with relevant experience to better understand your issue

## **Funding to Support People with Mental Health Issues**

Mental health organisations in the UK can apply to the Allen Lane Foundation for grants of up to £15,000 to support work with people experiencing moderate or severe mental health conditions. The programme aims to reduce isolation, stigma and discrimination associated with mental health while promoting recovery and inclusion. Priority is given to specialist mental health organisations and user-led groups. One-to-one counselling or therapy is not funded under this stream.

Funding can be awarded as a single grant or spread over two or three years, with most awards averaging £5,000–£6,000. Eligibility is geared to smaller, community-focused organisations. As a guide, local groups typically have annual income below £100,000, while UK-wide organisations should be under £250,000.

The Foundation does not fund individuals or public bodies such as schools, NHS organisations or councils.

Funding can cover running and core costs, salaries, or project expenses, with emphasis on lasting impact and organisational sustainability.

Applicants are encouraged to demonstrate clear outcomes, strong local need and how the work will complement existing mental health support in their communities.

All applications received now, until early December will be considered in the lead up to the following Trustee meeting in February 2026.

## **Grants for Musicians and Bands**

The PRS Momentum Music Fund is open to Artists/Bands that are at a crucial tipping point in their careers, showing current progression and growth as artists with the potential to significantly develop their careers over the next two years. Applications can be submitted by the artists themselves or by those working on their behalf, such as a manager, an independent label, or a publisher. **Grants of £5,000 to £15,000 are available, with an average of around £10,000.** 

Grants can cover:

- Recording i.e. a new album, EP, single, producer, engineer, mixer fees, studio hire, session musician fees, etc.

- Marketing and promotions i.e. PR, radio plugger, digital marketing, music videos, merchandise production, etc.
- Purchase of equipment / software / hardware (covers up to 20% of costs)

Priority will be given to expenditures that help the artist develop professionally and creatively. The next deadline to apply to the PPL Momentum Music Fund is the 27th of October 2025.

## **Grants of up to £5,000 Available to Not-For-profit Theatres**

Grants of up to £7,500 are available to not-for-profit theatres across the UK through the Small Grants Programme. The Linbury Trust and the Mackintosh Foundation have together committed a total of £150,000 over five years to address the urgent need for essential repairs and improvements.

The grant is designed to fund small capital works, installation of key plant and machinery, and projects that make buildings digital-ready. It aims to improve resilience, sustainability, accessibility and audience diversity. Revenue costs and surveys are not eligible.

Eligible applicants must own or manage a theatre under a title or lease of at least five years. They must stage a minimum of 30 live performances per year and hold charitable or not-for-profit status with two years of certified or audited accounts.

### The next deadline is 5 pm on Friday 16 January 2026.

Decisions will be notified up to 16 weeks after closing. Applications are made via the online form, following the guidance notes and webinar available on the Theatre Trust website.

## **Grants for Specialist Dementia and End-of-Life Training**

Hospices that are members of Hospice UK can apply for grants of up to £2,000 to deliver specialist training courses for care home staff, with a particular focus on dementia care for people approaching end of life. The funding programme has allocated £50,000 to support at least 25 hospices across the UK, with organisations able to apply for up to two grants per year.

The funding which is made available through the Wolfson Foundation Hospice Care Home Training Programme covers a comprehensive range of costs associated with delivering CPD-accredited training, including teaching expenses, venue hire, travel costs, and catering. Both new courses and repeat sessions of existing training programmes are eligible, though the funding cannot be used for in-house training. The programme supports single training events as well as series of sessions designed to enhance care home staff skills and knowledge.

Interested hospices must submit their applications through the online grant's portal at least one month before their planned training date. Successful applicants will be responsible for all aspects of training delivery, from needs assessment and promotion to evaluation and reporting. The scheme operates on a first-come, first-served basis, and all granted funds must be claimed within 12 months of the award.

# Funding to Enhance Educational Outcomes for Disadvantaged Children and Young People Under 26

UK-registered charities and exempt charities (including CIOs) can apply for grants of between £10,000 and £25,000 to improve educational outcomes for children and young people under 26 who face significant disadvantage and struggle to access vital services

The funding is made available through the Steel Charitable Trust's United Kingdom Under-26 Fund and can be used to support:

## Types of activities that can be funded include:

- **Educational opportunities:** Projects that provide learning, skills development, or access to further education for young people.
- Access opportunities: Initiatives that help young people access support, services, or experiences that would otherwise be out of reach due to economic or social barriers.
- **Projects targeting groups or locations facing disadvantage:** Work that supports young people in circumstances or communities experiencing economic hardship or social exclusion.
- Capital and running costs: Funding can cover specific project costs, including salaries for stated roles, IT upgrades, building renovations, or other capital expenditures, as long as these are detailed in the application 65.
- **Ongoing or new projects:** Both new project costs and contributions towards existing projects are eligible, provided the beneficiaries are mainly under 26 years old65.
- **Restricted funding:** All grants are for restricted use, meaning they must be spent on the specific project or purpose outlined in the application

Applicants must have at least one year of accounts and a minimum annual income of £100,000. Projects must benefit mainly under-26s across the UK (excluding Luton) and cannot be retrospective, overseas, or support individuals directly.

Applications are reviewed on a quarterly basis and the next closing date for applications is the 15th of October 2025.

# Grants Available to Support Children and Young People who have Experienced Significant Crises

Grants of up to £2,400 are available to vulnerable children and young people who have experienced significant crises that have impacted on their well-being and education. The funding aims to provide tailored support packages that can include essential items and activities to enhance learning and development, such as laptops, books, Wi-Fi access, educational materials, and extra-curricular activities, etc.

The programme supports those who have been victims of physical or sexual abuse, emotional abuse or neglect by a parent or caregiver, and those who have witnessed or been direct victims of domestic abuse, etc. Children aged 2-18 living with parents or carers and young people up to age 20 living independently, provided they are engaged in at least 12 hours of education or training per week. To be eligible, beneficiaries must be living on a low income, experiencing financial hardship, and have moved beyond the immediate crisis while engaging with support services.

Applications for the "Chances for Children" grants are accepted on a rolling basis, with no specified closing date.

# **Funding for Activities to Improve the Lives of the Elderly**

Small grants are available to fund projects to improve the lives of the elderly across the UK. Home Instead Charities awards grants for well-being events, activities, or pastimes that prevent social isolation and loneliness among adults over 55.

## **Eligibility Criteria:**

- small grass-roots organisations can apply for funding up to £500

## Eligible projects may include:

# **Equipment Grants for Disabled and Disadvantaged Young People**

Grants have no set maximum limit, although applications for under £5,000 are unlikely to be considered. # Friends of the Elderly – Grants for Older People on Low Incomes

Small grants of up to £400 (£500 for couples) are available to support vulnerable older people living on low incomes in England and Wales. Grants can be used to cover essential expenses such as purchasing a new fridge, paying unexpected bills, food, clothing, or covering gas and electricity costs.

# Tackling Loneliness Amongst Older people and Adults with a Disability
