# <u>Erewash Voluntary Action CVS – Erewash Small Grant</u> Scheme

Derbyshire County Council Public Health, Derbyshire County Council Adult Care Services and Erewash Borough Council fund the Erewash Small Grant Scheme.

Community groups and organisations can apply for up to £1,500.

The Erewash Small Grant Scheme has three priority themes and applicants must meet at least one of the themes to be eligible to apply. The priority themes include:

- Health Inequalities
- > Community Wellness
- Building Resilience

Applications can be made by voluntary or community groups with a constitution, registered charity or charitable incorporated organisation, community interest company or social enterprise and other not for profit organisations.

The grant scheme is not open to statutory organisations including Parish Councils.

# National Lottery Community Fund - Awards for All England

Voluntary, community organisations and Schools, etc across the UK can now apply for grants of up to £20,000 from the National Lottery Community Fund – Awards for All programme. This represents a significant increase from the previous maximum grant size of £10,000. Projects can last for up to two years.

The funding boost is intended to support organisations in delivering new or existing community led activities. Eligible projects must achieve at least one of the following objectives:

- Bring people together to build strong relationships within and across communities
- Improve places and spaces that matter to communities
- Help individuals reach their potential by providing early support
- Assist individuals, communities, and organisations facing difficulties due to the cost-of-living crisis

#### Organisations eligible to apply include:

- Constituted voluntary or community organisations
- Constituted groups or clubs
- Registered charities
- Charitable incorporated organisations (CIOs)
- Not-for-profit companies
- Community interest companies (CICs)
- Schools (provided the project benefits and involves the surrounding communities)
- Statutory bodies (including local authorities, town, parish, and community councils)
- Community benefit societies

The application deadline is 16 weeks before the start of the project or activities.

# Impetus - Youth Employment Grant Round

Open for applications from organisations supporting young people to prepare for and find work, with a particular focus on young people from ethnic minority backgrounds.

The fund are looking for organisations that:

- Support young people to find work or develop work related skills
- Primarily work with young people from ethnic minority and socio-economically disadvantaged backgrounds

#### Successful organisations will receive:

- £100k in unrestricted grant funding per year, for two years (with potential to continue thereafter)
- Expertise, coaching and capacity-building support from our investment team

## **Armed Forces Covenant Fund Trust**

Refurbishment Grants programme The Armed Forces Covenant Fund Trust is delivering the Veterans' Capital Housing Fund on behalf of the Office for Veterans' Affairs. The Veterans' Capital Housing Fund supports projects that contribute to the wider aim of ending veterans' homelessness by providing affordable and viable homes for veterans.

Under this programme, the Armed Forces Covenant Fund Trust will award grants of up to £75K, on behalf of the Office for Veterans Affairs, towards projects that assist in the refurbishment or extension of rental accommodation that will offer high quality support for veterans with a housing need.

Eligibility – To be eligible for this funding, you must be one of the following:

- A registered charity that can show it works with veterans or
- A registered social housing provider that can show it works with veterans.

This is a refurbishment grant programme for capital projects that will support refurbishment and/or extension of accommodation for veterans. You can apply for grants of up to £75k for capital refurbishments projects lasting up to one year. We anticipate that most grants will be below £40k.

Themes and priorities – We want to support projects that need help to refurbish existing housing for veterans. This could be transitional or permanent housing. You can apply to this programme if your project will:

- enable refurbishments of existing affordable homes for rent to veterans
- enable refurbishments of sites that increase the availability of veteran housing
- ensure properties meet decent homes and energy efficiency standards

A strong application will show how the project will contribute to the aims of the government's ambition to reduce veteran homelessness and end rough sleeping,

who you would work with to deliver the project and how the benefits of the work would contribute to the overall aims of this programme.

# <u>Department for Levelling Up, Housing and Communities - Community Ownership Fund</u>

The UK government has announced that the final round of the £150 million Community Ownership Fund is now open for expressions of interest.

This is a £150 million initiative from the Department for Levelling Up, Housing and Communities and is designed to help community groups take ownership of assets that are at risk of being lost, such as:

- community centres
- cinemas and theatres
- galleries
- museums
- music venues
- parks
- post office buildings
- pubs
- shops
- sporting and leisure facilities

#### Eligible applicants include:

- voluntary and community organisations
- parish, town and community councils

The maximum grant available per project is £2 million although it is expected that most awards will be for up to £250,000 of capital funding. 20 % match funding is required (10% in exceptional circumstances).

Revenue funding of up to £50,000 or 20% of total capital funding applied for is also available.

Successful organisations will be invited to submit a full application when the round 4 bidding window opens.

## **Bernard Sunley Foundation**

Grants are available to charities, specialist schools, CIOs, and other not-for-profit organisations including scout and guide groups, and housing associations, that are working to raise the quality of life for people in England and Wales.

The Bernard Sunley Foundation aims to provide greater opportunities for the young, elderly, disabled, and disadvantaged by supporting capital projects in the areas of:

- Community
- Education
- Health
- Social welfare

•

The types of projects that could be supported include:

- improvements to village halls
- supporting children and adults with special educational and learning needs
- improvements to hospices and treatment clinics
- supporting day centres for the elderly

The Foundation offers three levels of grants. These are large grants of £20,000 and above; medium grants of up to £20,000 and small grants of £5,000 and under. Large and medium grants are considered and agreed upon at Trustees' meetings. Small grants are agreed by Trustees on a monthly basis and form the majority of grants awarded.

# Ministry of Defence - Armed Forces Day Grant

Communities that want to show their support for the Armed Forces by hosting an Armed Forces Day event in 2024 can apply for a grant from the Ministry of Defence.

The grant is match-funded, meaning it can cover up to half the total cost of the event, with a maximum value of £10,000 depending on the size and format of the event. For example, applicants that raise £5,000 can apply for a grant of £5,000.

The funding can be used to pay for road closures, decorations, flags and banners, local or national newspapers and radio advertisements, marshalling, security, first aid, insurance, and PA and communications systems such as hand-held radios or other forms of communication for event organisers.

The funding cannot be used to pay for:

• hospitality, including food, drinks and accommodation

- military assets, including displays, equipment or military vehicles
- entertainment, such as bands or musicians, films or other entertainment military or otherwise
- transport for guests or organisers to or from the event

To apply for this grant, communities must first register their event on the Armed Forces Day website. Armed Forces Day takes place on the 29 June 2024.

#### Youth Music - Energiser Fund

Youth Music has launched a new funding programme aimed at increasing creativity in early childhood.

The Energiser Fund will award ten organisations with three-year grants of up to £120,000 to deliver creative projects for 2-4-year-olds who face barriers in England.

The funding will support a wide range of creative projects across different art forms that are co-designed with young children and delivered by organisations seeking to develop their co-design practice.

The types of organisations supported by the fund could include:

- A theatre company that specialises in work for early years
- A maintained nursery school that centres creativity in their curriculum
- A small CIC comprising freelancers delivering music and movement projects with 2-4-year-olds in a variety of community settings
- A museum or library that programmes literature and art activities for 0-5s and their families

Organisations will also be invited to participate in a programme of workshops, reflection sessions, and mentoring.

At least 20% match funding is required.

The deadline for applications is 5pm on the 5 April 2024.

## Veolia Environmental Trust

The Veolia Environmental Trust, which provides grants for community and environmental projects, has announced that it has opened its next funding round.

The Trust makes the following grants:

- Community Grants: These grants are open to constituted not-for-profit organisations and local authorities. They provide funding ranging from £10,000 to £75,000, aimed at creating or improving buildings or outdoor spaces for the benefit of the community. The maximum project size eligible for funding is £350,000.
- Habitat and Biodiversity Grants: Projects focused on conserving, restoring, or enhancing threatened habitats and/or protecting and increasing biodiversity can apply for grants between £10,000 and £75,000.
- Environmental Improvement Grants: For landscape-scale improvement projects, such as habitat creation/management and species protection, grants exceeding £75,000 are available.

The closing date for applications is 12 mid-day on the 11 April 2024.

The Screwfix Foundation has re-opened for applications from charities and not for profit organisations for projects that will fix, repair, maintain and improve the properties and community facilities of those in need by reason of financial hardship, sickness, disability, distress or other disadvantage throughout the UK.

Grants in the region of £5,000 are available for all kinds of projects, from repairing buildings and improving facilities in deprived areas, to decorating the homes of people living with sickness and disabilities.

# **Big Bike Revival Programme**

Local volunteer led-groups, social enterprises, and other not-for-profit organisations can apply for grants of up to £3,500 to deliver cycling events to get people back on their bikes this summer.

The Big Bike Revival Programme will support organisations across England to deliver a summer programme of activity that will encourage people who do not currently cycle regularly (once every two weeks or less) to consider either starting or returning to cycling.

This includes people experiencing:

- social, economic and health deprivation
- people from diverse backgrounds
- those facing multiple challenges

The programme supports three types of events:

- Learn to fix events offers basic services to repair cycles and provides essential checks to ensure cycles are safe to ride
- Learn to ride sessions offers instruction, training or skills for adults to learn to maintain or repair their cycle or learn cycle skills to help them feel safer when cycling
- Ride events offers led rides for adults to practise cycling locally

The funding, which is made available by the Department for Transport, can be spent on anything that supports the delivery of events such as staffing costs, consumables and venue or location hire.

## **Rowing Foundation**

Organisations, clubs, and schools involved in rowing can apply for grants of between £500 and £4,000 (up to 50% of the overall cost of the project) from the Rowing Foundation to support junior & student rowers, and adaptive rowing for all ages.

These grants are intended for groups who may have small funding requirements or be ineligible for other sources of funding such as the National Lottery.

The Rowing Foundation focuses on providing equipment such as boats, sculls, ergos, oars, and safety gear to encourage the participation of young people and the disabled in rowing.

The funding is being made available through two funding programmes:

- Equipment grants
- Refurbishment grants

To be eligible for funding, the projects or work must be non-elitist, for public benefit, and aim to benefit young people, those in education, or people with disabilities.

The next application deadline for equipment grants is the 20 May 2024. Applications for refurbishment grants can be made at any time.

## Village Halls Small Grants Fund

Defra funded grant scheme reopens for those managing rural community buildings. This is managed by ACRE who have also announced a new Chief Executive

This round has a lower award threshold of £2,000 to support smaller projects and make it accessible to more groups.

The grant fund has re-opened to new applicants who wish to undertake smaller projects such as disability access, toilet upgrades and new kitchens. Grant awards of between £2,000 to £5,000, and up to 20 per cent of eligible project costs, are on offer. Project expenditure must take place before 31 March 2025.

Deadline: The fund is expected to stay open until December 2024, however it may be withdrawn before this

#### Woodward Charitable Trust - Summer Playschemes

Each year the Trustees of the Woodward Charitable Trust set aside funds for summer playschemes for children from disadvantaged backgrounds between the ages of 5-16 years.

Trustees only fund programmes that run for a minimum of 2 weeks, 10 full days or 20 half days across the summer holidays.

Trustees will only fund up to 50% of the total cost of a scheme. Most grants awarded are in the range of £500 to £1,000. Around 35 grants are made each year.

Preference is given to:

- Small local playschemes that provide a wide-ranging programme of activities. Trustees prefer activities that are relatively inexpensive such as crafts and cooking, as well as outdoor activities and sport.
- Schemes that involve a large number of children.

Schemes where past users are encouraged to come back and help as volunteers.

## Jean Sainsbury Animal Welfare Trust

Charities registered in the UK and working to offer sanctuary, rehoming and rehabilitation to animals in the UK and/or internationally can apply for grants of up to

£35,000. Organisations involved with the conservation of wildlife, the rescue, rehabilitation and (where possible) release of animals are also eligible to apply.

The funding supports general running costs or capital purchases. The Trust encourages repeat applications from charities when further financial support might be given if funds allow.

## **Peoples Health Trust**

Local community organisations in specific areas in England, Scotland, and Wales can apply for grants of between £20,000 and £40,000 for nature-based projects that enhance the mental health of people who experience socio-economic disadvantage, discrimination and marginalisation.

The funding is being provided through the Peoples Health Trust's new Nature for Health grants programme has been launched in response to the growing recognition of the positive impact of nature on mental and physical health, the grant seeks to address health inequalities and promote the wellbeing and mental resilience of individuals and communities.

The closing date for stage 1 applications is 1pm on the 20 March 2024. Applicants successful at this stage will have until 1pm on the 1 May 2024.

#### Operating / Core Costs

Through the Operating/Core Costs grants programme the foundation provides funding towards the general costs of running an organisation. This means they can be used to help pay the organisations bills or rent and provide support towards salaries

#### Capital Projects

Through the Capital Projects grant programme the foundation provides funding of no more than 10% of a total project cost. However, for local community projects (e.g. village halls, community centres, places of worship, etc.), grants are unlikely to be over £30,000 regardless of the project size.

## **Funding Reminders**

#### Women's Aid - Flexible Fund

Women's Aid is pleased to be working with the Home Office and sector partners to help distribute an additional funding to provide one-off payments to survivors of domestic abuse to help them flee from their abuser, and to increase their stability and independence following on from a successful pilot distributed in May 2023.

From Wednesday 31st January 2024 until Sunday 31st March 2024, survivors of domestic abuse who do not have the financial means to leave their abusers, or to remain safely in their home, will be able to apply for a one-off payment of up to £500 for essential items such as groceries, nappies or clothing to help them and their children flee to safety.

For the first time, survivors can also apply for a further one-off payment of up to £2,500 to help secure a sustainable independent future, such as putting down a deposit for rental accommodation.

# National Lottery Heritage Fund

The Heritage 2033 strategy is centered around a simplified framework of four investment principles:

# <u>Peter Harrison Foundation - Opportunities Through Sport</u> Grant Scheme.

Charities and Community Amateur Sports Clubs (CASCs) throughout the United Kingdom can apply to the Peter Harrison Foundation Opportunities Through Sport grant scheme. The aim of the grant scheme is to provide opportunities for sport and physical activity at a grassroots level that enable people who are physically, mentally, socially, or economically disadvantaged to develop personal and life skills to fulfil their potential.

The grants can be used for a variety of purposes, such as funding new sports programmes, improving existing sports facilities, or providing training and support for sports coaches.

The Trustees welcome applications for physical activity initiatives that:

- Provide a focus for skills development and confidence building
- Have a strong training and/or educational theme
- Provide specialised sporting equipment or facilities required to open opportunities
- Have a high degree of involvement from beneficiaries and those with lived experience
- Have a plan for sustainability and seek to deliver a lasting legacy

The Foundations provide two levels of funding:

Major grants: between £5,001 and £30,000.

• Small grants: up to £5,000

Priority will be given to organisations with an annual turnover of up to £500,000.

# <u>Action with Communities in Rural England - Platinum</u> <u>Jubilee Village Hall Improvement Grant Fund</u>

Village halls across England can apply for grants to improve and modernise their facilities.

Launched by the Department for Environment, Food & Rural Affairs to mark the Queen's Platinum Jubilee in 2022, the Platinum Jubilee Village Hall Improvement Grant Fund will provide capital only grants of up to £5,000 for capital improvement projects to create welcoming spaces that encourage more people to make use of their village halls and bring people together.

The fund is being managed by Action with Communities in Rural England (ACRE).

Activities should seek to achieve one or more of the following outcomes for their communities:

- improved health and/or wellbeing and/or reduction in rural loneliness
- positive impact on the local environment, contributes towards net zero
- support for the local rural economy
- promotion of community cohesion
- Grants are intended to support smaller capital projects such as:
- boiler replacements

- insulation
- toilet upgrades
- new kitchens

Awards can be made to cover 20% of eligible project costs.

The fund is expected to stay open until December 2024, however it may be withdrawn before this.

## Central England Co-operative - Community Dividend Fund

The Central England Co-operative has re-opened its Community Dividend Fund to support good causes, groups and charities in central England.

Groups can apply for grants of between £100 and £3,000. The grants are available to members of Central England Co-operative for projects that aim to develop and improve communities by supporting access to:

Grants are available to full members of Central England Co-op in Derbyshire.
