Erewash Voluntary Action CVS – Erewash Small Grant Scheme

Derbyshire County Council Public Health, Derbyshire County Council Adult Care Services and Erewash Borough Council fund the Erewash Small Grant Scheme.

Community groups and organisations can apply for up to **£1,500**.

The Erewash Small Grant Scheme has three priority themes and applicants must meet at least one of the themes to be eligible to apply. The priority themes include:

- Health Inequalities
- Community Wellness
- Building Resilience

Applications can be made by voluntary or community groups with a constitution, registered charity or charitable incorporated organisation, community interest company or social enterprise, other not for profit and parish councils.

The grant scheme is not open to statutory organisations.

FCC Communities Foundation – Community Action Fund

The FCC Community Action Fund provides grants of between £2,000 and £100,000 to not-for-profit organisations for amenity projects eligible under Object D of the Landfill Communities Fund (LCF). The Fund supports the provision, maintenance or improvement of community facilities.

Only applications for projects sited within 10 miles of an eligible FCC Environment waste facility can be accepted, you can check if you are located near an eligible site by clicking Apply and completing the pre-application eligibility check.

Applications from the following types of organisations can be made:

- Registered Charity which operates a community facility
- A Church or Parochial Church Council
- A Parish or Town Council or a Management Committee or User Association acting on behalf of a Parish or Town Council
- A Local Authority
- A CASC Registered Sports Club

The FCC Community Action Fund is oversubscribed, and types of projects are limited as to what is funded and paid for. Plan your application, download and read the Guide for Applicants or click on Apply and follow the pre-application eligibility check.

All grants require applicants to secure a contributing third party (CTP) payment. This is a very specific payment required to be paid to the landfill operator and should not be confused with match funding.

Capital Fund - Re-opening of Derbyshire Environmental Trust's Grant Programme

The Derbyshire Environmental Trust (DET) is repeating its own funding scheme in 2022. In recognition of the slightly longer period between funding rounds and its 25th Anniversary the Trust has more than doubled the available funding for one year only.

Up to £100,000 in total is available for distribution to a number of projects. The maximum award is £25,000 and the minimum £2,500.

This year there are two key changes to the assessment criteria in that the Trust will give consideration to environmental impact and carbon reduction and energy efficiency, with a preference not to support projects reliant on fossil fuels where alternatives are an option. In addition to the other funding criteria, which remain unchanged from recent years, the Trust will also take note of the level of deprivation in the area of the project this year.

The closing date for applications is 3 October 2022 with decisions in December 2022 or January 2023.

Youth Fund - Paul Hamlyn Foundation

Not-for-profit youth organisations that support young people (aged 14 - 25) facing disadvantage can apply for grants of up to £150,000 spread over three years through the Paul Hamlyn Foundation Funding to Support Youth Organisations.

The Youth Fund supports organisations whose main purpose is about helping young people who face complex transitions to adulthood.

The Foundation is looking to support organisations to:

- Sustain, grow or prepare to grow the organisation's impact.
- Improve, consolidate and spread practices which empower young people to shape their lives and lead change (sometimes called asset-based approaches).
- Support and champion people with lived experience in the leadership and operational delivery of this work, particularly people who are most affected by systemic oppression and or discrimination.

Gamble Aware Community Resilience Fund

The Gamble Aware Community Resilience Fund (CRF) aims to provide grants to enable organisations to respond quickly to the cost-of-living crisis, and the impact this has had in exacerbating gambling harms and increased exposure to them. Charities and organisations are able to apply to the fund, with smaller organisations or pilot projects being awarded up to £150,000 and larger organisations or projects can apply for up to £350,000.

Grants of up to £5,000 are available to small, registered charities to fund equipment and services to support disabled and disadvantaged children under the age of 13 across the UK.

The Toy Trust fund:

Friends of the Elderly - Grants for Older People

Friends of the elderly provide support for older people affected by loneliness and grants for those living on a low income. Through the Grants for Older People programme they provide grants of up to £400 to older people who are of/over state pension age and have savings of less than £4,000.

Funding is currently being provided through four schemes:

- Home Essentials to help with the cost of replacing everyday items,
- small home repairs and mobility adaptations.
- Digital Connection to help older people get online.
- Financial Support to help with unexpected bills.
- Essential Living Costs including clothing, food, medicines and books.

Applications must be made via a third-party Referral Agent such as charities, local authority and social services representatives.

Grand Plan

Grants of £1,000 are available to support people of colour in the UK to develop and deliver a wide range of creative and cultural projects.

The funding is made available by the Grand Plan, which awards ten grants every two months to support projects for which £1,000 would make a huge difference, ranging from poetry, paintings, fashion, zines, music, food, flowers, and photographs to workshops or events.

It can be used to cover costs such as equipment, courses, time, materials or travel – anything needed to create and deliver a new cultural project.

National Lottery Community Fund - #iwill Fund

The National Lottery Community Fund and the Department for Digital, Culture, Media and Sport are putting an extra £12 million of funding into the #iwill Fund to create thousands of new youth social action opportunities for young people across England.

The #iwill Fund distributes its investment by working in partnership with other funders that match #iwill Fund monies on at least a £1:£1 ratio and develop funding programmes that enable more young people, particularly from less affluent communities, to take part in social action projects such as campaigning, fundraising and volunteering.

This new funding is primarily aimed at those who are new to the #iwill Fund and are developing their own youth social action funding projects through grant funding to other organisations.

The Listening Fund

The Listening Fund is seeking applications from youth-focused charities and not-for-profit organisations in England who are working to support young people aged 10-30 who have experienced injustice into positions of leadership.

The funding is being made available through the Advisers' Fund, which will award grants of up to £40,000 for two years to allow organisations to create leadership opportunities that enable disadvantaged young people to shape their own strategies, support services and systems. It will target young people facing various issues, including those leaving care or experiencing homelessness, school exclusion, poor mental health, and sexual exploitation and abuse.

A total of £500,000 is available for this funding round.

The deadline for applications is 6pm on the 28 July 2022.

Youth Music - Trailblazer Fund

Grants of up to £30,000 are available to organisations in England for projects that support children and young people facing barriers to make, learn and earn in music.

The funding is made available through the Youth Music Trailblazer fund which supports organisations who want to trial work for the first time, test a new way of working, or disrupt the status quo - or all three.

To be eligible for support applications must meet one of the following themes:

- Early years
- Disabled, d/Deaf and neurodivergent young people
- Youth justice system
- Young people facing barriers
- Young adults
- Organisations and the workforce.

A Trailblazer project could be:

- A new community organisation testing out different ways of supporting nurseries to embed music-making into their day-to-day activities.
- A Music Education Hub that wants to disrupt the status quo of their local music scene by setting up a Youth Board that has budget & power to make decisions about how the hub is run.
- An established youth centre trialling a programme of music activities for the first time.
- Music curriculum activity in a special school, Pupil Referral Unit or Alternative Provision setting.

Organisations less than one year old can apply for a maximum grant of £15,000. A minimum of 10% match funding is required.

Power to Change - Powering Up Programme

Power to Change is to reopen its Powering Up Programme to support community businesses across England to develop and grow their leadership skills and their organisations. This round will support up to twenty organisations that are looking to deliver changes within their business to help them to become more environmentally sustainable, and up to twelve businesses looking to learn how digital skills could help their business develop and grow.

The Powering Up programme offers a tailored support package for each community business and is worth up to £20,000 in total, this can be drawn down over a 12-month period. It includes:

- Paid access to technical and business support providers (up to £9,000) who are brokered in to meet the specific needs of your community business
- Professional development and wellbeing support (up to £3,000) such as leadership coaching, peer mentoring, team building and mental health support.

An £8,000 unrestricted grant to support you as a community business leader, and your team, to engage in the required support of the programme. This could be to cover your time, back fill a post, purchase essential equipment, or cover other expenditure that supports development and resilience of your community business.

The programme has a cross-cutting theme of diversity, equity and inclusion. Priority will be given to applications from areas of England facing high levels of deprivation, and organisations supporting or led by Minority Ethnic communities.

Grants plus business support are available to social entrepreneurs that are looking to start or grow an existing social venture. The funding is being made available through the UnLtd the leading provider of support to social entrepreneurs in and around the UK.

The grants are being made available through two funding streams:

- Grants of up to £15,000 to grow an existing social enterprise
- Grants of up to £5,000 to start a new social enterprise.

UnLtd are committed to providing 50% of their awards to Black, Asian and minority ethnic social entrepreneurs, and/or disabled social entrepreneurs.

To be eligible applicants need to be:

Grants of up to £25,000 are available to public and not-for-profit organisations, local authorities and private owners of heritage for projects to explore, test and grow new ways of working across the heritage sector.

The funding, along with six months of support, will allow organisations to test and grow new ways of working within the heritage workforce.

Applications are currently being accepted for the Explore phase which aims to define clearly stated problems within the workforce that will help to develop solutions for the testing phase.

The funding is being made available through the National Lottery Heritage Innovation Fund.

Black Equity Organisation and Sky - Future 100 Growth Fund

The fund will provide grants of up to £15,000 along with strategic business advice, supply chain access, coaching and mentoring.

Good Things Foundation - Digital Inclusion Capability Grant

Funding is available to support members of the Online Centres Network to build their ability to deliver digital inclusion.

Through the Digital Inclusion Capability Grant, the Good Things Foundation will provide the following:

- Training & Support - As part of the programme community partners will be able to access training and support to help them to develop their capabilities to deliver digital inclusion and secure funding for their organisation.
- Capability Building - Up to 220 existing community partners over two rounds will receive grant funding from Good Things Foundation to build their sustainability and capability for digital inclusion, whilst also accessing training and support.

There are two grant sizes: a smaller £2,000 allocation and a larger £5,000 allocation.

Projects need to be delivered between Thursday 1st September 2022 and Tuesday 28th February 2023.

McCarthy Stone Foundation - Small Grants Programme

Grants of up to £5,000 are available to grassroots and volunteer-led charities, community groups, CICs and social enterprises working with intergenerational activities and/or community regeneration that benefit the health and wellbeing of older people across the UK.

The funding is made available through the McCarthy Stone Foundation - Small Grants Programme to support older people facing isolation, loneliness, or poor health, young people who may be falling behind personally and academically and communities in need of regeneration.

To be eligible for funding, applicants must have an annual income below £500,000 and no more than 12 months of operating costs in reserves.

Applicants should submit an expression of interest in the first instance by the 31 July 2022.

International Tree Foundation - UK Community Tree Planting Programme

Schools, community groups and non-governmental organisations within the UK can apply for grants of up to £10,000 for community-led tree-planting projects.

Through the UK Community Tree Planting Programme, the International Tree Foundation aims to conserve, restore and protect the UK's native species whilst raising community awareness of the importance of trees and forests to both the environment and human well-being.

There are two tiers of funding available:

- Small scale: A maximum of £1,000 is available for projects of up to 1 year in duration. This could be small community woodland, orchards, hedging projects
- Larger scale: Projects to range from 1000 – 10,000 trees, with a maximum price equivalent to £1.50/tree (inclusive of tree protection). Most suitable for community woodland or hedging projects.

Trees must be planted in public / publicly accessible spaces: sites that are readily accessible to the public, including schools, parks, rights of way, and sites managed by community groups.

Applications can be submitted at any time until the 16 December 2022.

National Churches Trust - Cornerstone Programme

Listed and unlisted Christian places of worship, of any denomination, can apply for a grant towards the cost of urgent structural repairs.

Grants of between £10,000 and £50,000 are available for projects costed at more than £100,000 including VAT. Also considered are projects that introduce kitchens and accessible toilets to enable increased community use where the cost is more than £30,000 including VAT.

All grants will represent a maximum of 50% of the project cost.

Charities in the UK can now apply for funding of between £35,000 and £200,000 through the Scottish Power Foundation.

The Foundation particularly welcomes applications that will support the most vulnerable people in society. Applications must address at least one of the ScottishPower Foundation's strategic aims:

- Education, Training and Research
To support education, training and research in general, prioritising innovation in order to contribute to energy sustainability.
- Biodiversity and Climate Change
To support the protection of the environment and to increase biodiversity, to actively contribute in the fight against climate change.
- Art and Culture
To protect and safeguard artistic and cultural heritage by promoting conservation and restoration of the arts and supporting local development.
- Social Initiatives
To contribute to sustainable human development by supporting the most vulnerable people and groups.

To apply, charities will need to complete an eligibility form. Charities that pass the eligibility test will receive an email with a link to the application form.

Mutual Aid Fund

Grants are available for mutual aid groups across the UK to support capacity building and sustainability projects that address the distinct challenges in adapting to a post-COVID environment. Grants of between £1,500 and £5,000 are available.

Funding is for projects and activities that meet all the following criteria:

- Clearly helps a group adapt post-COVID.
- Demonstrates a key contribution to a group's sustainability.
- Be completed within nine months.

Examples of what can be funded include:

- Upskilling group members, such as in their technological capacity.
- Piloting a programme that would help secure more sustainable sources of funding.
- Creating the capacity to design and implement a strategy/programme that would contribute to the sustainability of the group, including paying an existing group member or hiring a consultant.
- Buying equipment necessary for the sustainability of the group, such as fridges for a food

Derbyshire County Council Members Community Leadership Scheme

Each County Councillor usually has £3,860 to give to local groups, this year an additional £3,860 has been allocated bringing their total to £7,720. Next year councillors will receive £3,860 plus £1,500 Platinum Fund to give local groups organising activities to celebrate the Queen's Platinum Jubilee.

Groups seeking funding should contact their local county councillor to explain the nature of the project, amount sought, what other funding is available and how it will benefit the community.

Erewash Borough Council – Members Grant Scheme

For the 2021/22 financial year, each Erewash councillor has £250 award to organisations within their ward (where applicable some Councillors will have an additional amount available to them as a result of carrying forward unallocated grant funding from 2020/21). It is for each councillor to determine which project(s) or organisation(s) they wish to support. The scheme allows a wide degree of flexibility in the type of project a councillor may support and the amount (minimum £50) they wish to allocate, subject to approval.

Activities that complement the council's draft core priorities:

- A safe, clean and welcoming borough
- Improved access to services
- Delivering efficient and effective services that residents need
- Creating opportunities for economic growth and prosperity
- A well run and efficient council
-

Organisations (including registered charities, community and voluntary groups, Community Interest Companies, Social Enterprises) within the councillor's own ward, or councillors may join together to support a project covering two (or more) wards.

- Councillors can allocate the entire £250 to one organisation, but where multiple organisations are to be awarded funding, there is a minimum award of £50 per organisation.
- Capital purchase items.
- Match funding for a project. Funding will be agreed but not allocated until the applicant confirms that all match funding is in place.

The scheme is administered by the council's Community Engagement Officer, colin.handley@erewash.gov.uk However, organisations are advised that EBC Councillors are responsible for fully completing and signing grant application forms before they are submitted to the Community Engagement Officer.

Foundation Derbyshire - The Police and Crime Commissioner Community Investment Fund

Derbyshire Police and Crime Commissioner Angelique Foster has launched a second round of funding from her Anti-Social Behaviour Prevention Grant worth £100,000. These could include sports and creative arts diversionary programmes, radio/film-making activities, drop-ins for young people, CCTV, community clean-ups, intergenerational schemes, mentoring projects, education initiatives and parental support programmes.

Commissioner Foster is eager to support projects that take positive action against anti-social behaviour, in particular those that wish to offer some diversionary activity programmes over the summer holiday period.

Grants of up to £5000 will be allocated to successful applicants who can show evidence of how they will make a difference to Derby and Derbyshire's communities

The second is 1st July to 30th September.

Selected museums and galleries across England can now apply for funding to improve exhibition spaces and increase accessibility.

The Museums and Galleries Improvement Fund is financed equally by the Department for Digital, Culture, Media and Sport (DCMS) and the Wolfson Foundation. Over the last 20 years, the two organisations have provided more than
